Prayers were led by Lay Preacher, Ms Elizabeth O'Connor.

1. Declarations of Interest

Members were reminded that any disclosable pecuniary interests should be declared as required by the Localism Act 2011 and any personal or prejudicial interests should be declared as required by the Council's Code of Conduct for Members.

Councillors Griffiths and Threlfall declared a personal interest. The nature of the interest was that they were members of the Rawstrone Committee for Freckleton Community Centre, the roof of the which was subject of a capital bid to be considered as part of the budget proposals.

2. Budget Procedure Rules

The Mayor reminded members that the procedure rules for budget council differed to those of ordinary meetings. As such she referred them to the procedure rules contained within their agenda papers

Decision Items

8. <u>Medium Term Financial Strategy Update, Including General Fund, Capital Programme and Treasury</u> <u>Management for 2023/24 to 2027/28</u>

Councillor Karen Buckley presented the budget proposals and in doing so thanked the Finance team and all budget holders for maintaining the council's healthy financial position.

She advised that the medium term financial strategy report described the council's finances as robust. This was to be welcomed as other councils not faring as well, with seven out of ten councils surveyed by the Local Government Association reported to be using their reserves to balance their budgets. Under current funding arrangements Fylde was projected to need to draw on reserves in two years time. Councillor Buckley cautioned that this would be subject to the detail of annual financial settlements from the government. Fylde had exercised prudence and caution since 2008, which was correct to protect services for residents.

Councillor Buckley reported that all upper and lower tier councils across Lancashire were due to set maximum council tax rises this coming year, representing the difficult financial climate facing all councils. She advised that it was proposed to increase the average council tax by 2.99% or £6.54 on a band D property.

Turning to the proposed car parking fees, Councillor Buckley advised members of a correction to the agenda, where the proposed fees for 1-2 hours parking in St Annes Square and on Wood Street had been incorrectly stated when presented to Executive Committee and Internal Affairs Scrutiny Committee as £2.50 and should have read £2.60.

Councillor Buckley advised there were no proposals to add to the revenue budget. In terms of the capital expenditure, it was recognised there were a number of sizeable schemes already underway or yet to be delivered and for that reason this year there were a small number of additional relatively modest schemes. The schemes were to add fencing at Fairhaven Lake, footpaths improvements at Ashton Gardens, to install a new heating system at the depot, and a contribution towards the replacement of the community centre roof at Freckleton.

She concluded by thanking consultation respondents and the Internal Affairs Scrutiny Committee for their consideration and support for the budget proposals.

Councillor Gaunt seconded the proposals and agreed with Councillor Buckley that the council was taking proactive steps to protect its revenue budget. She drew members attention to the process for determining the budget through the consideration of pertinent factors such as uncertainty around the local government finance settlement, pay and price inflation pressures, and investment income and borrowing needs. She cautioned that material sources of income that supported the revenue budget which included the local government finance settlement, New Homes Bonus and the business rates retention scheme may only remain in place until March 2025. It was therefore important members were aware of the significant risk to the council's finances.

Councillor Gaunt confirmed that the outturn position was a forecast surplus of £425k for 23/24 and a forecast surplus of £375k for 24/25 with sizable forecast deficits for subsequent years.

Councillor Gaunt turned to the proposed capital schemes and reminded members of several other capital schemes currently in progress. She highlighted the risks which centred around the complexity of the work, price inflation consideration and a potential need for future external borrowing.

In regards to reserves balances, Councillor Gaunt asked members to note the forecast balance on the Capital Investment Reserve, on 31 March 2025, would be £2.602m. The Funding Volatility Reserve was expected to be £4.145m on 31 March 2025. She explained the reserve was there to cushion the impact of future funding reductions and support economic development. Councillor Gaunt advised that the General Fund Reserve, which supported the day-to-day revenue working of the council, was expected to have a balance as at 31 March 2024 £4.751m. She further advised that the Chief Financial Officer was recommending a raise in the minimum level of the General Fund reserve to £1m to maintain a stable financial environment.

In concluding, Councillor Gaunt asked that her thanks to the Finance team for their work in preparing the budget, and to the Leadership Board for their collaboration on the budget, be recorded.

Councillors Threlfall, Redcliffe, Nixon, Dixon, Evans and Morris spoke in support of the proposals.

Councillors Dixon, Evans and K Buckley thanked officers across the council for their prudent use of council resources and their delivery of services for the residents, with a special thanks to those officers who worked to identify and secured grant funding.

It was therefore RESOLVED;

- 1. To note the recommendations of the Executive Committee meeting of 19th February 2024 and the Internal Affairs Scrutiny Committee meeting of 20th February 2024, and approved as follows:
 - (a) The revised estimates for 2023/24 and the revenue budget for 2024/25 as set out in Appendix E, which includes recommended transfers to the Capital Investment Reserve in 2023/24 and 2024/25 equivalent to the balance of the revenue surplus for those years, currently estimated at £0.595m in 2023/24 and £0.375m in 2024/25;
 - (b) The budget proposals and changes to Reserves and Balances as set out in Appendices F & H, to include approval that the Council will act as the accountable body for any of the new capital schemes (as indicated) in Appendix F;
 - (c) The Capital Strategy 2024-28, including Prudential Indicators and Limits, set out in Appendix G; which incorporates the Treasury Management Policy, the Capital Programme, the Treasury Management Strategy, the Investment Strategy and the Minimum Revenue Provision Statement;
 - (d) The updated Useable Reserves & Balances Policy as detailed in Appendix H;
 - (e) An average Band D Council Tax of £225.43 for 2024/25 (excluding Town and Parish precepts), which is a 2.99% increase from the 2023/24 average Band D charge;
 - (f) The Special Expenses policy as set out in Appendix I; which includes that:
 - for the purposes of charging special expenses, both the special expense costs and the tax bases relating
 to the areas of Lytham and St Annes will each be aggregated and the Council Tax charge per property
 at each band level will be the same across the whole area; and
 - the annual special expense charge per property will be set for 2024/25 with a 3.06% increase on the 2023/24 level, that being £83.39 per band D property; and

- the annual borough wide charge per property will be set for 2024/25 with a 3.06% increase on the 2023/24 level, that being £177.75 per band D property; and
- the budget resource to be allocated to delivering concurrent services and chargeable as special expenses for 2024/25 will be set at a sum equivalent to the annual special expense charge per property (band D equivalent) multiplied by the tax base for the special expense area; and
- (g) The schedule of fees and charges for 2024/25 as detailed in Appendix J (Members should note that the draft schedule of fees and charges presented to the February 2024 Executive Committee and Internal Affairs Scrutiny Committee meetings has been updated in respect of the proposed fee for 1-2 hours parking on St Anne's Square and St Anne's Wood St car parks which were incorrectly stated as £2.50 and have been updated to £2.60); and
