# **FAIRHAVEN TO CHURCH SCAR COAST DEFENCE WORKS**

# **Summary Note**

- The major engineering elements at Church Scar are substantially complete. The remaining activities include:
  - o The reinstatement of the protected grassland,
  - Installation of balustrades/handrails,
  - Installation of the Scallop Seats, and other street furniture (lighting, signage, etc.).
- The contract requires the contractor VBA Ltd to be responsible for Church Scar up until the contract Completion Date which is 30/03/20. VBA Ltd being obliged to maintain Church Scar (and the whole works) for the first year following Completion. Whilst every effort will be made to secure access earlier than March 2020 this cannot be guaranteed and will be subject to contractor agreement after all necessary works have been completed.
- The latest public newsletter (December 2018) highlighted the above position, and stated that that it is an aspiration of Fylde Council to take-over and re-open Church Scar earlier than planned; as and when it becomes practicable to do so (with consideration to the commercial viability of the same also). - The site compounds are fully set up and operational at Stannah Bank Car Park and St Pauls Car Park for the construction works at Fairhaven.
- The steel sheet piling has been completed at Fairhaven, the haul road and crane pads are currently being constructed; and the construction of the new revetment has commenced.
- Procurement of the construction of Granny's Bay is to be undertaken, planned for February 2019, following the completion of the design.
- The Customer Drop In Centre has now had 858no people attending since its opening, with 260no people signed up for email notifications for the latest newsletters and general information.
- The overall Scheme remains on budget and time, with a current forecast actual completion of November 2019 (although this may extend until Spring / Summer 2020 with the works at Granny's Bay).
