Commentary is provided to explain why performance is currently not on target, with details of any corrective action.

PM28: Number of households living in temporary accommodation was 15, target is 6.

This indicator monitors the number of households living in the Councils temporary accommodation. A number of clients have been accommodated who have complex issues, and the Council has had to accommodate a number of clients when their private rented accommodation was closed as a result of enforcement action taken by the Council.

#### PM32: Average time accommodated in B&B - all homeless households (days) was 45, target is 0.

The target of 0 is set because guidance is that B&B should be avoided. B&B has been used only when necessary due to the lack of suitable alternative temporary accommodation.

PM34: Average weeks to accommodate all homeless households rehoused into permanent accommodation was 12, target is 9.

This indicator reflects the length of time accommodated before a household is rehoused into permanent accommodation. There have been a number of households waiting longer than expected for suitable accommodation which has increased the overall average time taken to re-house.

PM97a: The length of time for applicants on the waiting list for a Disabled facility grant (weeks) was 78, target is 0.

The length of time for applicants on the waiting list has increased during the year from 52 weeks to 78 weeks. Demand for DFG remains high and exceeds the resources available. An increase in resources has been announced for 2015/16 and it is hoped that this will help to prevent further increases.

PM97b: Number of applicants on the waiting list for a Disabled Facilities Grant was 80, target is 0.

*The number of applicants on the DFG waiting list has also grown during the year from 75 to 80, see commentary above (PM97a) for further information.* 

Commentary is provided to explain why progress has exceeded target, with details of how this will be maintained.

# PM29: % of cases where homelessness prevented and households able to remain in own home or assisted was 90, target is 86.

Fylde BC have a proactive approach to prevent homelessness which has resulted in homelessness being prevented for 90% of closed housing advice cases. This measure will be changed to monitor 'PM29a **Total number** of housing advice enquiries' and the 'PM29b Total number of housing advice enquiries where **homelessness has been prevented and applicant has remained in their home or assisted to alternative housing**'.

PM27: Percentage of high risk food hygiene inspections completed - Category A to C (quarterly) was 100, target is 90

The performance reflects the % of category A - C rated food hygiene premise inspections that have been completed from the inspection programme for the year 2014/15. The continued dedication and commitment of the food safety team has brought about this excellent performance.

PM98: Number of households in mortgage difficulty approaching the LA received appropriate advice was 19, target is 40

This has been much lower throughout the year. The target was based on the number of households in mortgage difficulty from previous years, however this year has seen reduction in the number of possession notifications from the banks therefore less people to contact to offer advice. The target for 2015-16 has been reduced to reflect this.

PM99: Number of households that received financial assistance from the council to prevent repossession was 4, target is 2.

The number is above target as resources were used to prevent repossession in the rented sector both private and social.
