Matter under consideration:	The Corporate Plan is the high-level strategic document that is part of the Council's budget and policy framework. The plan covers a four-year period with the current plan coming to an end on March 31 st , 2020. The new Corporate Plan covers the period 2020 to 2024 and has been developed over the last few months, it is intentionally presented as a 'plan on a page' to make it easier for a wider audience to use. The Plan covers the ambitions for the next four years with some of the
	main actions linked to the ambitions for the next rour years with some of the main actions linked to the ambitions. The actions are reviewed each year to take into account changes in legislation, service demand, resources and technology as well as wider public sector or regional issues (i.e. unitary status or combined authority), the current Coronavirus crisis has led to a rethink in many service delivery areas that may have a long term impact.
	The Corporate Plan is part of the performance management framework of a local authority and is used to inform the operational and more detailed actions of the Directorate Service Plans that are developed each year. The Plan is informed by partners, elected members and current legislative or regulatory requirements the council must fulfil. It has been subject to consultation with all stakeholders, partners, elected members and employees, with all the feedback included as Appendix 2 for your information. The consultation feedback has been used to develop the final draft of the 2020-2024 Corporate Plan which is included as Appendix 1, several responses to the consultation are issues that will be used to inform the operational delivery of some services through the Service Plans.
