LICENSING ACT 2003

THE LICENSING ACT 2003 (HEARINGS) REGULATIONS 2005 PROCEDURE FOR THE CONDUCT OF HEARINGS

1. Preliminary

- 1.1. Under the regulations, the Licensing Authority is required to determine the procedure that it proposes to follow at any hearing under the Act. This document sets out the procedure that Fylde will normally follow.
- 1.2. A panel may decide to follow a different procedure at any hearing. If it does, it will specifically draw attention to any departures from the procedures set out in this document and the reasons for them.
- 1.3. Please refer to the regulations for other rules about procedure

2. Interpretation

In this procedure, the following words or phrases have the following meanings:

3. Before the hearing

- 3.1. At least ten days before the hearing, the panel will meet to consider:
 - 3.1.1. If the circumstances set out in regulation 9(1)apply, whether to dispense with holding a hearing;
 - 3.1.2. What, if any, particular points it considers it will want clarification on at the hearing from a party under regulation 7(1)(d), and
 - 3.1.3. What time limit to set under regulation 24.
- 3.2. If it is not practicable for the panel to meet to consider these matters, the convenor may ascertain the views of panel members separately and give effect to the majority view as if it had been reached in a meeting of the panel.

4. Opening the hearing

- 4.1. The convenor will identify all parties to the hearing who are present. The convenor will also identify any persons who are present who intend to assist or represent any party and any witnesses.
- 4.2. The convenor will then explain to the parties the procedure to be followed at the hearing, specifically drawing attention to any departures from the procedures set out in this document and the reasons for them. The convenor will also inform the parties that the proceedings will be recorded.
- 4.3. The panel will then consider any request by a party under regulation 8(2) for another person to appear at the hearing. The convenor will give any party who has made such a request (or their representative) which the panel proposes to deny an opportunity to address the panel about their request. The panel will then re-consider the request.
- 4.4. The convenor may invite any officer to carry out any functions under this paragraph.

5. Listening to the parties

- 5.1. Each of the parties will then be invited to:
 - 5.1.1. Open their case by addressing the panel;
 - 5.1.2. Give any further information requested by the panel under regulation 7(1)(d);
 - 5.1.3. Present the evidence of any witness; and
 - 5.1.4. Conclude their case by addressing the panel.
- 5.2. The order in which the parties will be invited to put their cases will be in the discretion of the panel, except that a party who is an applicant will be invited to put their case last.

6. Questioning the parties

- 6.1. Members of the panel may, following the conclusion of the case of each party, ask questions of that party or any witness appearing for them.
- 6.2. A party or their representative may only question another party if they have asked for permission from the panel after the panel members have finished questioning that party or their witness. The panel will only give permission if it is satisfied that the questioning will provide useful information about a matter relevant to their determination which is unlikely to be placed before the panel without such questioning

7. Time limits

Each party will be limited to the time set by the panel under regulation 24 in which to exercise their rights provided in paragraphs 5 and 6.2. The convenor will require the party or their representative to close their case or cease their questioning immediately this time limit is reached.

8. Considering the decision

- 8.1. The panel will consider their decision in private.
- 8.2. No officers will retire with the panel except for the committee administrator. The committee administrator may, if requested to do so, provide procedural, but not legal or technical, advice to the panel. The committee administrator will also assist the panel by drafting and finalising the wording of the panel's decision, if requested by the panel.
- 8.3. The panel may, while it is considering its decision, seek advice from legal or licensing officers. Officers will limit their advice to the specific issue identified by the panel and will leave the room where the panel is considering its decision as soon as that advice has been given and understood.

9. Announcing the decision

- 9.1. When the panel has made its decision, the public part of the meeting will resume.
- 9.2. The convenor will read out the decision of the panel, or may invite the committee administrator to do so. The meeting will then close or move on to the next business.

APPLICATION FOR REVIEW OF A PREMISES LICENCE - AHMETS, 3a HENRY STREET, LYTHAM

PUBLIC ITEM

This item is for consideration in the public part of the meeting.

SUMMARY

The Licensing Authority has received an application from Lancashire Constabulary to review the premises licence at Ahmets, 3a Henry Street, Lytham.

The Licensing Authority must therefore hold a hearing to consider the application.

RECOMMENDATION

 - (a) modify the conditions of the licence
 - (b) exclude a licensable activity from the scope of the licence
 - (c) suspend the licence for a period not exceeding three months
 - (d) revoke the licence
 - (e) take no further action

SUMMARY OF PREVIOUS DECISIONS

26th July 2013 – Application received for new Premises Licence for 3a Henry Street, Lytham. Following application additional conditions agreed with Lancashire Constabulary. Licence FY PN01000 relating to the premises first came into effect on 2nd September 2013 following approval to issue by Licensing Panel.

27th September 2016 – Minor variation application received to extend the non-standard hours at the premises for Bank Holiday weekends etc. This was granted on 12th October 2016.

The review is brought on behalf of Lancashire Constabulary following concerns that the Licence Holders are persistently committing Offences Contrary to Section 136 of the Licensing Act 2003 by serving hot food beyond the hours of which they are licensed to do so. These offences along with breaches to the operating schedule and
an increase in complaints of noise and anti-social behaviour within the immediate vicinity of the premises have led to this application. There has been an unwillingness by the Licence Holder to abide by the law despite numerous warnings from both the Police and Licensing Authority and as such the Police have strong concerns that the Licensing Objectives are not being properly promoted, especially in relation to the prevention of crime and disorder and the prevention of public nuisance.

Please provide as much information as possible to support the application (please read guidance note 2)

This Premises is Licensed as 3a Henry Street and is named Ahmet's Kebab House and Take-away, which is located on the busiest late night economy street in Lytham and is licensed to supply hot food until 01:30hrs on Friday and Saturday evenings and until midnight Sunday to Thursdays. Since July local residents and Councillors have voiced concerns regarding late night activities on Henry Street which then culminated in residents meetings and separate meetings for the licensees of Lytham where these concerns have been raised. Despite this the premises has continued to stay open beyond the licensable hours and thereby encouraging customers to remain on the street.

The Police were notified by Fylde Council that on 26th September 2016 a letter was sent to both Licence Holders following complaints received that the premises had operated beyond its licensed hours, namely 02:10hrs on 28th August & 3rd September and 00:40hrs on 4th September. In addition to this, when a visit was conducted on 21st September, there was no CCTV monitor connected to the system so the Licensing Officer was unable to confirm footage was being recorded. There was a screen in the public area of the premises; however, this was not linked to the CCTV system which is another breach of the premises licence conditions.

On 19th March 2017 at 01:25hrs PC Emma Pritchard attended the premises and spoke to Licence Holder Metin Mert as there had been some confusion from non-Licensing Police Officers as to the terminal hour that hot food was supplied. The previous licence stated 01:00hrs however the existing licence is until 01:30hrs on Friday and Saturday evenings. This could have easily been proven if the Premises Licence Summary was on display as is required by law, however PC Pritchard could not see this anywhere; she informed Mr Mert it was an offence not to have it on display and he thought it was in the Office somewhere. PC Pritchard advised him if he could not find it he would need to contact Fylde Council and order a replacement. He stated he would ensure this was in place as soon as possible. At this time the door was closed and no hot food was being served.

At 01:09hrs on 17th April 2017 Police received a report that a female had been headbutted by another female whilst inside the premises. PC Maccormaic attended and was told by staff they could not show him the CCTV footage or supply him with a copy at that time. This is a breach of a condition on the Premises Licence and as such a warning letter was sent to Licence Holders Ahmed and Metin Mert on 20th April to ensure this is in order for future incidents.

Following complaints from local residents and residents/ Licensee/ multi-agency meetings PC Pritchard attended Henry Street at 01:20hrs on Sunday 26th November. Although the alcohol on-licence premises in the area had all closed there was still many people present on the Street. PC Pritchard did not witness any disorder but there was a lot of noise from people talking whilst waiting for food or eating food on the street. At 01:40hrs PC Pritchard entered Ahmet's which was full to capacity with approximately 25 people waiting to be served hot food. PC Pritchard could not see a Premises Licence on display and the door was still open with all lights on. PC Pritchard spoke to Licence Holder Metin Mert and advised him he was committing an offence every time he was supplying hot food to a customer. Only when asked did Mr Mert turn off some lights and shut the door and finally stopped serving hot food at 01:52hrs. When guestioned about this Metin Mert said "it's not the crime of the century" and that "We don't always open late just a couple of times a month when we get busy to keep the business afloat". Metin Mert did not attempt to excuse this behaviour or apologise and PC Pritchard was concerned he was not taking his obligations as a Licence Holder seriously and would continue to commit offences.

Fylde Council Officers Chris Hambly and Joanne Gallagher attended Ahmet's at 19:40hrs on Friday 1st December 2017 and spoke to Metin Mert and advised him of the requirement to serve hot food in line with his licensable hours. Chris Hambly noted there was a Premises Licence on display however it was on a wall out of Public view. Chris Hambly asked to see recordings of the CCTV system however Licence Holder Metin Mert had forgotten the password and was unable to prove it was recording; Metin was also unable to link the television screen up to the CCTV system which is also a requirement of the Premises Licence.

At 01:25hrs on Sunday 3rd December 2017 PS Helen Parkinson attended the premises and saw that the Licence Holder Metin Mert was at the premises along with approximately 10 people ordering or waiting for food. At 01:30hrs the lights were dimmed and the door was locked, however PS Parkinson then witnessed another 6 people come to the door and Metin Mert unlocked it and allowed them in. This would clearly indicate that the licence holder wants to make it appear that the premises is closed but is still willing to breach his licence and continue to serve hot food despite numerous warnings. At 01:40hrs all the customers had left and the premises was closed. PS Parkinson also saw that the television screen that should show customers on CCTV was displaying a blue screen with the 'Magic' radio logo. PS Parkinson confronted Metin Mert who said "arrest me then, go on arrest me", when asked if this was his attitude towards breaking the law he replied "Yes it is"

At 01:30hrs on Sunday 10th December 2017 PC Sarah Roberts was outside the premises whilst on routine response in the area and noted that the door was shut and some lights were off, however there was still lots of people inside waiting and being served hot food. Unfortunately at that point she was diverted to an incident and could not return to check the premises.

Recorded Crimes/ incidents relating to the premises from 01/01/2016 to 11/12/2017

Below is a summary of incidents reported to Police; these incidents can be read in full in the appendices of this review. Only incidents which directly specify Ahmet's Takeaway are shown; incidents which have taken place on Henry Street which may have occurred due to the saturation of licensed premises in the area have not been included.

At 00:53hrs on 17th April 2017 a female contacted Police and stated she was assaulted whilst in the premises. She states another female was in the queue behind her being aggressive and was then head-butted. This female then went home. A Police Officer attended Ahmet's and staff have said 'there wasn't much in it' and they were unable to show or download CCTV. Victim did not proceed with complaint. Log reference LC-20170417-0068 Crime reference WA1706528.

At 23:28hrs on 19th February 2017 a member of staff requested Police attend the premises as males are fighting and being aggressive inside and out of premises, no description of those involved as member of staff is 'in the back'. Police attend but half had left and others were not making any complaints. Crime report for Public Order was submitted with no further action. Log reference LC-20170219-1395/ Crime reference WA1702853.

At 01:22hrs on 12th November 2016 A. Mert requested Police attendance because there were people in the premises making too much noise and he wants Police to ask them to leave. He states they are not fighting or being threatening or abusive just being generally loud. Informant has been advised to be more robust and refuse to serve them and close if necessary. Log reference LC-20161112-0095

At 22:35hrs on 10th July 2016 Metin Mert contacted Police regarding a heated exchange between 6 travellers. Police attend, no reports of any crime. Log reference LC-20160710-1640.

At 23:33hrs on 2nd April 2016 a member of staff contacts Police and states there is fighting in the premises. Initially it was reported as 2 males fighting and a female had got caught in the cross fire. Crime report submitted for a female being hit by a coin during a scuffle. Offender had left upon arrival and so only line of enquiry was CCTV, however no CCTV could be provided from the premises due to technical difficulties. Log reference LC-20160402-1421 Crime reference WA1604646.

At 01:38hrs on 19th March 2016 a member of staff contacted Police and stated a group of drunken customers were being abusive in the shop. Other members of staff have got them outside and locked the door but they are gathered outside and being rowdy. At 01:42hrs staff recalled to say all aggressors have now gone so Police are no longer required. Log reference LC-20160319-0109.

Historic issues at the premises

Ahmet's was previously licensed at the commencement of The Licensing Act 2003 at 3 Henry Street. A variation was submitted, and following a Licensing Committee hearing a variation to increase Licensing hours to 1am was granted on 8th August 2008. The Licence Holder at this time was Ahmet Mert, although Metin Mert had involvement in the business as he spoke to Police to ask if they could purchase the plasma screen for the CCTV after the Licence had been granted.

On 29th May 2009 Licensing Officer PC Steve Hardman attended the premises and sent a warning letter regarding breaches of licence conditions at the premises. This visit was made after complaints received that the premises was open beyond its permitted hours, however when attempting to prove/ disprove this PC Hardman discovered the CCTV system had not been recording. He also noted the television screen being used was 14", not a minimum of 32" which the licence specifies. PC Hardman also noted there was no attempt made to clear litter or food that had accumulated on the highway.

At 01:20hrs on 18th June 2011 PS Sarah Salisbury visited the premises and witnessed customers being served hot food at a time when the supply of hot food should have ceased at 01:00hrs. A warning letter documenting this was sent to Ahmet Mert.

PC Andy Scarisbrick attended the premises at 01:34hrs on 24th December 2011 and there were 30 people inside. At this time the premises were only licensed until 01:00hrs.

At 01:30hrs on 30th December 2011 PC Darren West attended the premises and advised Ahmet Mert of his licensable hours and said he was struggling to get people out and it was a one-off. He was advised to be more robust with this.

The premises moved next door to 3a Henry Street and applied for a new licence for the takeaway which commenced on 7th September 2013 which allows hot food to be supplied until midnight Sunday-Thursday and 01:30hrs Friday and Saturday. Both Ahmet and Metin Mert signed a mediation agreement to add licence conditions to the operating schedule on 29/08/2013.

Licensing Act 2003 – 3a Henry St, Lytham

I write further to my visit to the above mentioned premises of the 21st September following a complaint that the premises has been operated beyond the hours permitted to by the licence. The Premises Licence FY PN1000 permits Late Night Refreshment, Sunday to Thursday 2300 to midnight and Friday and Saturday 2300 to 0130. The complainant advises that the premises has been open until 0210 on the 28th August and 3rd September 2016 and 0040 on the 4th September. The Guidance issued under S182 of the Licensing Act 2003 comments, "The 2003 Act affects premises such as night cafés and take away food outlets where people may gather at any time from 11.00pm and until 5.00am. In this case, supply takes place when the hot food or hot drink is given to the customer and not when payment is made. For example, supply takes place when a table meal is served in a restaurant or when a take-away is handed to a customer over the counter."

Please note that to ensure an offence is not committed, any food orders must be handed over to the customer before the relevant terminal hours stated above.

I would also refer you to the following conditions on the Premises Licence reference

- 3.1 CCTV will be installed internally and externally at the premises and will comply with the following:
- i. The system will display on any recording the correct time and date of the recording
- ii. VCR tapes or digital recording shall be held for a minimum of 31 days and 21 days respectively after the recording is made and will be made available to the Police or any authorised persons acting for a Responsible Authority for inspection upon request.
- iii. The system will, as a minimum, record images of the head and shoulders of all persons entering the premises.

At the time of the visit, there was no monitor provided with the system and as such, viewing of any recorded material could not take place.

3.5 The premises shall have installed a wall mounted screen, no smaller than 32", mounted in a position within the premises so that patrons can view live recorded CCTV footage.

Whilst a larger screen is installed in the premises, it is not linked to the CCTV system.

- 3.8 A clear, legible and conspicuous notice requesting patrons to avoid causing noise, nuisance or disturbance to local residents shall be displayed at every exit. Such a notice is not displayed within the premises.
- 3.12 No nuisance shall be caused by noise coming from the premises or by vibration transmitted through the structure of the premises.

The Licensing team are in receipt of complaints of noise emanating from this and other premises in the vicinity. Appropriate measures to reduce any noise coming from the premises and its customers should be considered to ensure compliance with the licence.

Please note that in accordance with Section 136(1) of the Licensing Act 2003, "a person commits an offence if a) he carries on or attempts to carry on a licensable activity on or from any premises otherwise than in accordance with an authorisation b) he knowingly allows a licensable activity to be so carried on."

The maximum penalty for this offence is six months imprisonment and/or a fine not exceeding £20000. I would also stress, that the Licensing Act 2003 has introduced a power of review, where a responsible authority or interested party, such as a resident living in the vicinity of a premises, may ask the Licensing Authority to review the licence because of a matter arising at the premises in connection with any of the four licensing objectives, in this instance "the Prevention of Public Nuisance".

The Guidance issued in accordance with the Licensing Act does comment that licence holders should be given early warning about problems identified at a premises and that a failure to respond to such warnings would lead to a decision from one of the responsible authorities to request to a review.

This staff member will be able to show recent data or footage with the absolute minimum of delay when requested to a Police Officer or to a Local Authority Enforcement Officer.

At approximately 01:09hrs on 17th April 2017 PC 2015 Maccormaic attended this premises following a report that a female had been headbutted by another female whilst inside the premises. He was told by staff that they could not show him the CCTV footage or supply him with a copy at that time but would keep the CCTV for Police.

Action Taken: following complaints from local residents regarding concerns on Henry street in Lytham two night time economy meetings were arranged by Fylde council who attended along with police and licensees on 1st September and 18th October 2017. Metin Mert attended the first of these meetings on 1st September.

At approximtaely 01:20hrs I was on Henry street in Lytham at which time all the bars on the street had closed and there was a large number of individuals on the street congregating. Some were waiting for taxis and others were eating take away food or waiting for food. I saw that Ahmets takeaway was very busy and customers were queueing out of the door.

this continued and at 01:40hrs I went inside Ahmets where there were approximately 25 people waiting for food, I approached the counter where the licence holder Metin Mert was preparing hot food and he said "hi do you want some food", I asked what time he was closing and he said "when I've served all these people" I then asked what time he was licensed until and he said "half one" I pointed out that it was now 01:40 and every time he was supplying hot food to people he was committing an offence. He then said "what do you want me to do kick everyone out?" I knew that doing this could create disorder so I said no but the door was open and new customers were still coming in to get food so he should at least shut the door. metin then said "give me 5 minutes to serve these people then I'll come outside and speak to you". i also saw that his father Ahmet Mert was also in the premises serving hot food.

I then waited outside of the premises who then shut the door and turned the external lights off in the premises. Whilst I was waiting I saw people approaching the takeaway trying to get in and had to tell people that it was now closed.

At 01:52hrs hot food ceased to be supplied and the lights were switched off and Metin locked the front door and came outside to speak to me.

once outside I said to Metin that he cannot supply food beyond 01:30hrs as he is committing offences and he said "it's not the crime of the century" and that "people get away with a lot more, there's murderers and rapists out there and my moral compass isn't that bad." he also said it was a particularly busy night which i was surprised at because it was 'black friday' weekend and also the weekend before the usual pay day so thought it would be quieter than usual. Metin then said "we don't always open late just a couple of times a month when we get busy to keep the business afloat". I said that as a result of recent complaints in the area he should be going above what he would normally be doing to prevent issues in the area, not committing offences. I then advised him there would be a Pubwatch meeting at 10am on that Tuesday which he said he would attend. (this is a condition of his licence for ambiance).

Metin did not apologise or attempt to excuse this activity and did not seem to care and I was left with the impression that he would continue to breach his licence in the future as he did not consider this a 'serious offence' and had already admitted to conducting unlicensable activity in the past. Therefore I said I would be in touch as to whether he is prosecuted for unlicensable activity or whether I submit a review of the licence.

Metin Mert did not attend the Pubwatch meeting on Tuesday 28th November nor did he send a representative or his apologies.

As a result of the premises opening past their licensing hours it led to a congregation of people stood on the street eating food which in turn led to more noise over a longer period.

I SAID HE NEEDS TO CONCENTRATE ON GETTING HIS OWN PREMISES IN ORDER INSTEAD OF WORRYING ABOUT OTHERS.





Premises Licence Review

With reference to the above licence review I have the following representation from Environmental Protection.:

The Department is aware that there are a number of residents who are dissatisfied with noise and anti-social behaviour originating from the clientele who use the various licensed premises on Henry Street.

The noise continues into the early hours on a Thursday/Friday/Saturday on a weekly basis. Residents have arranged and attended meetings to discuss the issues and these have been highlighted as follows:

Noise from vehicles (car engines and door slamming);

Patrons shouting, screaming and singing in the street into the early hours;

This takes place every week.

Officers have visited the area at night and have witnessed the issues described. Other incidents include people lying down on the pavements, car horns sounding, people gathering in front of the bedroom windows of the Homestead (a retirement apartment block) and large gatherings of customers outside of Ahmet's.

This disturbance continues until 1am and then there is noise as patrons wait for taxis or move on

As this establishment is open late in to the early hours of the morning, the noise from people remaining continues and people gather at this establishment rather than immediately moving on from the Henry Street drinking establishments once they close. Residents are therefore disturbed for longer than necessary.

I would support a reduction in operating hours as this would limit the time that patrons and others are lingering on Henry Street making noise and disturbing residents.

I understand that you are looking at this.

The council received a planning application to amend the lawful opening hours in 2013, which has our reference 13/0480, with the intention that they would then comply with those under the premises licence. This was submitted at a time when the premises were trading as a hot food takeaway under planning permission 97/0275. In addition to confirming that use, condition 3 of planning permission 97/0275 restricts the use to 8am to 11.30pm (Sun-Wed) and 8am to midnight (Thurs.-Sat)

At the time of the submission of the 2013 application the premises was being converted away from the hot food takeaway use and I was advised that this was to be a restaurant, with application 13/0480 including an external freezer to support that use as well as a proposal to amend the hours. The change of use from a hot food takeaway to a restaurant is in planning terms a change from A5 to A4 and is permitted development that can be undertaken without planning permission under Class B of Part 3 to the GPDO.

As part of my assessment of the application I had concerns over the location of the freezer to the rear and how it could impact on the availability of refuse storage facilities for the premises, and for others in the area given the restricted nature of the alley that serves the rear of the premises and the presence of some residential flats in the area. I also had contact from neighbours who raised concerns that the land ownership shown on the application was not in fact accurate. In an attempt to clarify this I met on site with the applicant (Metin Mert) and the landlord (unknown) on 24/9/13. The outcome of this meeting was that clarity was to be provided to me of the ownership situation to confirm that the freezer and bin storage areas that were proposed for No. 3a were actually within its control. I never received any further correspondence on this and so the application has not been determined.

Premises Licence Review

- 1. I am Christopher Hambly, and I am currently employed as the Environmental Health Manager at Fylde Borough Council. Part of my role is the line manager for the Licensing Team which administers and enforces the provisions of the Licensing Act 2003. I submit this representation on behalf of the Licensing Authority to the review application dated 13th December 2017 submitted by the Police relating to Ahmets, 3a Henry Street, Lytham (Ahmets). I have the delegated authority to submit a representation on behalf of the Licensing Authority.
- 2. Ahmets is one of two late night take away premises located in the centre of Lytham, the licence FY PN1000 being first issued in September 2013.
- 3. The Premises Licence Holders are Ahmet Mert and his son Metin Mert. Metin is also the licence holder of a bar called Ambiance located next door to Ahmets at 3 Henry Street, Lytham.
- 4. Whilst Ahmets has only been licensed at this address since September 2013, the licence holders did previously operate a late night takeaway at 3 Henry St. I am unsure of the date the premises first started trading but following the implementation of the Licensing Act 2003, a licence was required for the sale of hot food and/or hot drink between 2300 and 0500 hours. An application was submitted by Ahmet Mert for the grant of a licence (FY PN0022) which subsequently came into force on the 24th November 2005. That licence was subsequently surrendered in February 2015 when the property was converted to Ambiance.

- 5. I have checked the council's records from when Ahmet Mert operated Ahmets from 3 Henry Street and note that warning letters have been issued by Fylde Council on the 6th February 2006, 17th May 2006 and 7th January 2013. The records also show that the Police wrote to Ahmet Mert regarding breaches of the Ahmets licence on the 29th May 2009 and 22nd June 2011.
- 6. I submit copies of those letters as exhibit CH01 and make specific reference to the letters from the 6th February 2006, 17th May 2006 and 22nd June 2011 which refers to Ahmets operating beyond its licensed hours.
- 7. As indicated above, the current licence FY PN1000 came into force on 2nd September 2013 and is issued to Ahmet and Metin Mert and authorises the provision of late night refreshment between 2300 and midnight Sunday to Thursday and 2300 0130 on Fridays and Saturdays.
- 8. When considering the provision of late night refreshment, the Guidance issued under S182 of the Licensing Acts states at 3.13:
 - "Shops, stores and supermarkets selling only cold food and cold drink, whether it is immediately consumable or not, from 23.00 are not licensable as providing late night refreshment. The 2003 Act affects premises such as night cafés and takeaway food outlets where people may gather to purchase hot food or drink at any time from 23.00 and until 05.00. In this case, supply takes place when the hot food or hot drink is given to the customer and not when payment is made. For example, supply takes place when a table meal is served in a restaurant or when a takeaway is handed to a customer over the counter."
- 9. In September 2016 a complaint was received from a resident of Henry Street regarding a number of matters but also alleging that Ahmets was operating beyond its licensed hours. I subsequently visited Ahmets to discuss the matter and wrote to Ahmet and Metin Mert on the 26th September 2016 reminding them of the licensed hours and conditions attached to the licence. I attach a copy of that letter as exhibit CH02.
- 10. At 1940 on Friday 1st December 2017, I visited Ahmets with Joanne Gallagher from the Licensing Team. The visit was in response to information received from the Licensing Unit of Lancashire Constabulary that the premises had been operating beyond its licensed hours the previous weekend. The police reported to the council that on Sunday 26th November 2017 Ahmets was open and serving customers until 0152 when it should have been closed at 0130.
- 11. I spoke with Metin Mert who was immediately defensive. I explained to him the purpose of our visit and that I wished to go through the licence conditions with him. At the time of the visit, there were no licensable activities taking place. Whilst at the

premises I checked through the following conditions which have been placed on the licence and should be complied with at all times that licensable activities are taking place (i.e. sale of hot food and drink):

Condition 2.1

The Premises Licence Holder shall ensure customers are served as quickly as possible and moved to stop them congregating.

N/A at time of visit

Condition 2.2

Notices shall be placed in the premises requesting that patrons behave and keep noise down.

There were no notices displayed so this is a failure to comply with a condition of the licence.

Condition 2.3

Customers shall be requested to respect the neighbours and leave quietly. *N/A at time of visit*

Condition 2.4

There shall be no adult entertainment at the premises. *N/A at time of visit*

Condition 3.1

CCTV will be installed internally and externally at the premises and will comply with the following:

i. The system will display on any recording the correct time and date of the recording ii. VCR tapes or digital recording shall be held for a minimum of 31 days and 21 days respectively after the recording is made and will be made available to the Police or any authorised persons acting for a Responsible Authority for inspection upon request.

iii. The system will, as a minimum, record images of the head and shoulders of all persons entering the premises.

I requested Metin to demonstrate the system but he was unable to access the machine as he had forgotten the password. We were therefore unable to confirm that it had in fact been recording and how far back the recordings go and so this is a failure to comply with a condition of the licence.

Condition 3.2

A staff member who is conversant with the operation of the CCTV system will be on the premises at all times the premises are open to the public. This staff member will be able to show recent data or footage with the absolute minimum of delay when requested to a Police Officer or to a Local Authority Enforcement Officer.

As above – whilst a system was in place, Metin was not in a position to be able to

operate it and so this is a failure to comply with a condition of the licence.

Condition 3.3

The licence holder shall notify the Police Licensing Unit on any occasion when the CCTV is to be inoperative for a period in excess of one working day and shall provide a certificate from a competent person stating the reason for the system being inoperative and the measures which have been taken to satisfy the licence conditions.

N/A at time of visit

Condition 3.4

Bi-annually documented maintenance checks of the CCTV system, including the recording system, will be undertaken by the licence holder to ensure that the system is in good working order and fit for purpose.

No checks are undertaken and Metin appeared to be unaware of this requirement

Condition 3.5

The premises shall have installed a wall mounted screen, no smaller than 32", mounted in a position within the premises so that patrons can view live recorded CCTV footage.

I noted that a wall mounted screen is installed in the premises which Metin assured me is 32", however the CCTV footage was not displayed upon it. Metin went through the channels on the television but was unable to link it to the CCTV and so this is a failure to comply with a condition of the licence.

Condition 3.6

No persons under the age of 16 will be allowed on the premises after 23.00. *N/A at time of visit.*

Condition 3.7

No boxing machines to be in operation in the premises.

There are no boxing machines at the premises.

Condition 3.8

A clear, legible and conspicuous notice requesting patrons to avoid causing noise, nuisance or disturbance to local residents shall be displayed at every exit. *No such notices were displayed.*

Condition 3.9

Risk assessments carried out by or on behalf of the licence holder which relate to a licensing objective will be available for inspection by an officer or a responsible authority.

No risk assessments were available for inspection so this is a failure to comply with a condition of the licence.

Condition 3.10

The licence holder shall arrange adequate supervision of any queue inside the premises and any which may form to gain entry to the premises.

I asked Metin what arrangements they had for queue supervision. He replied that the arrangements were "experience" as he has worked there since he was 16 years old and there is 40 years' experience from his father. I would be concerned as to whether this is considered to be adequate supervision. Metin is also the Premises Licence Holder and Designated Premises Supervisor of a neighbouring licensed premises which may sell alcohol until 0100 and is closed by until 0130. Whilst this second premises does employ door staff, Metins ability to supervise will be affected by matters elsewhere. I am unaware of Ahmet Merts involvement in the late night trade and how often he is present at the premises.

Condition 3.11

Fixed seating will be provided for customers.

There is a small amount of fixed seating available for approximately 4 people. However, there was also a large unused pizza oven left on the floor by the seating. I was told that it was being stored there whilst they were waiting for it to be removed.

Condition 3.12

No nuisance shall be caused by noise coming from the premises or by vibration transmitted through the structure of the premises.

No current issues.

- 12. I had a short discussion with Metin regarding the requirement to comply with the licence and that the conditions are not aspirational. The conditions numbered 2.1 to 2.4 are those steps to promote the licensing objectives he included in his operating schedule on his application for a licence whilst those numbered 3.1 to 3.12 were attached by the Licensing Authority following a representation by either a Responsible Authority or "other person" after a hearing. I noted that the Licence Summary was not publically displayed but was on a wall facing a staircase leading from the upstairs of the premises. I asked Metin where the actual licence was to which he replied it was in car as that was where he kept his paperwork. The failure to publically display the Licence Summary is a criminal offence.
- 13. I found Metin to be extremely negative and reluctant to accept any responsibility for the multiple failures to comply with the conditions of the licence. Rather than acknowledging what may be viewed as failings in the operation of his own business, he suggested that we, as Officers, were looking at the wrong premises and should be directing our efforts elsewhere.
- 14. When discussing the licence conditions with particular reference to the servicing requirement, for the CCTV system, he asked, "whats the harm?". Myself and Ms Gallagher then left the premises. Ms Gallagher has prepared a separate statement of her involvement with Ahmets which I submit as exhibit CH03. I will be calling her as a witness at the hearing to address the panel.
- 15. As referred to in point 3, Metin Mert is the Premises Licence Holder and Designated Premises Supervisor of Ambiance, a licensed premises located next door to Ahmets.

- 16. On behalf of the Licensing Authority, my strong view is that Metin Mert has little respect for the licensing objectives and is failing to promote them. Both Ahmet and Metin have been warned by licensing officers regarding operating beyond their permitted licensing hours. Despite the warnings they have knowingly served late night refreshment to the public later than their licence permits them to because they consider it necessary to do so rather than either take additional steps to prevent access to the premises by customers or to vary the licence to seek later hours.
- 17. The Licensing Authority will always work with premises who are willing to co-operate but in relation to this licensed premises, and the other licensed premises the Merts have connections with there has been a consistent failure to comply with the conditions on the licence and a failure to co-operate with licensing officers.

I refer to my visit to your premises during the evening of Friday 29th May 2009, during which the conditions of your premises licence reference **FY PN0022** were discussed and I would make the following observations regarding the conditions as outlined below, of the premises licence:

Annex 2 Condition 4 states – "When the premises are approaching maximum occupancy, customers who have been served shall be requested to leave the premises"

It would appear from a number of complaints received against your premises over the last 2 week that there are substantial noise issues from a large number of customers queuing within and outside your venue.

Annex 3 Condition 1 states – "Risk assessments carried out by or on behalf of the licence holder which relate to a licensing objective will be available for inspection by an officer of a responsible authority"

There were no risk assessments available for inspection at the time of my visit.

Annex 3 Condition 2 states – "A clear, legible and conspicuous notice requesting patrons to avoid causing noise, nuisance or disturbance to local residents shall be displayed at every exit".

There were no such signs in place at the exit to the premises at the time of my inspection.

Annex 3 Condition 3 states "Frequent collection of all litter dropped within the vicinity of the licensed premises to be collected and removed at the licence holder's expense at a frequency

of not less than 60 minute intervals during the premises opening hours. This includes washing away to the gutter and spilled food.

It was clear at the time of my inspection that there had been no attempt to remove any of the litter / food that had accumulated on the highway.

Annex 3 Condition 4 states "The premises shall be equipped with a closed circuit television system which meets the criteria detailed in the Lancashire Constabulary guidelines document, and which is well maintained and fully functional during the hours the premises are open to the public.

It became apparent that the CCTV had not been recording prior to my visit, when numerous attempts were made by your staff to retrieve images from the previous Friday evening, following on from complaints received that you were open beyond your permitted hours.

A copy of the CCTV minimum standards is attached as document SS1

Annex 3 Condition 6 states – "The premises shall have installed a wall mounted plasma screen, no smaller than 32", mounted in a position within the premises so that patrons can view live recorded CCTV footage"

The currently installed TV monitor does not satisfy these requirements, being of only approximately a 14" monitor.

I would also advise that in accordance with section 136(1) of the Licensing Act 2003 "a person commits an offence if a) he carries on or attempts to carry on a licensable activity on or from any premises otherwise than in accordance with an authorisation, b) he knowingly allows a licensable activity to be so carried on".

The maximum penalty for this offence is six months imprisonment and/or a fine not exceeding "20,000.

The Premises Licence FY PN1000 permits Late Night Refreshment, Sunday to Thursday 2300 to midnight and Friday and Saturday 2300 to 0130. The complainant advises that the premises has been open until 0210 on the 28th August and 3rd September 2016 and 0040 on the 4th September.

The Guidance issued under S182 of the Licensing Act 2003 comments, "The 2003 Act affects premises such as night cafés and take away food outlets where people may gather at any time from 11.00pm and until 5.00am. In this case, supply takes place when the hot food or hot drink is given to the customer and not when payment is made. For example, supply takes place when a table meal is served in a restaurant or when a take-away is handed to a customer over the counter."

Please note that to ensure an offence is not committed, any food orders must be handed over to the customer before the relevant terminal hours stated above.

I would also refer you to the following conditions on the Premises Licence reference FY PN1000;

- 3.1 CCTV will be installed internally and externally at the premises and will comply with the following:
 - i. The system will display on any recording the correct time and date of the recording
 - ii. VCR tapes or digital recording shall be held for a minimum of 31 days and 21 days respectively after the recording is made and will be made available to the Police or any authorised persons acting for a Responsible Authority for inspection upon request.
 - iii. The system will, as a minimum, record images of the head and shoulders of all persons entering the premises.

My name is Joanne Gallagher and I am employed as a Technical Enforcement officer based in the licensing team at Fylde Council.

On 30th January 2017 I received a telephone call from a resident of Henry Street, Lytham who informed me that Ahmet's Kebab House, 3a Henry Street, Lytham had remained opened beyond 1.30am during the previous weekend. Ahmet's benefits from a late night refreshment licence, number FY PN1000, which allows the licence holders Ahmet Mert and Metin Mert to serve hot food and drinks until 12.00am on Monday to Thursday and 1.30am on Friday and Saturday nights.

visited the premises on 2nd February 2017 and reminded Metin Mert that his late night refreshment licence finishes at 1.30am on Friday and Saturday nights and that this is the latest time the food should be served not the time that he takes the last order.

During the afternoon of 1st December 2017 I visited Metin Mert at Ambiance restaurant & bar. Metin is also the licence holder at Ambiance, a restaurant which is situated next door to Ahmet's Kebab House. During that visit I informed him that PC Emma Pritchard had advised me that she had spoken to him about the fact that Ahmet's was still open at 1.40am on Saturday night 25th November 2017 and asked him why, since the premises only has a Late Night Refreshment licence until 1.30am. Metin replied to me that it was busy and "it wasn't like he was raping kids". He also stated that by keeping the premises open he was keeping people off the street.

I suggested to him that he didn't need to be so defensive when challenged by authority figures and that sometimes it's better to accept constructive criticism and address failings when they are brought to his attention. I also advised him that the licensing regulations were there for a reason and he needs to comply with them. I informed Metin that Chris Hambly and I were working on Friday evening and we may call in to see him.

I visited Ahmet's Kebab House with Chris Hambly on Friday 1st December 2017 at around 7.40pm. Mr Hambly began to go through the conditions on the licence and it became apparent that the CCTV wasn't connected to the TV screen situated in the shop. When Mr Hambly questioned this Metin became very defensive with him and kept giving excuses as to why his CCTV wasn't working as stated on the conditions such as "it hasn't been his biggest priority". Metin was unable to access the CCTV recording system to provide evidence of past recordings as he had forgotten the password. (About an hour later I received a text message from him stating that he had now been able to access the system and including what appeared to be a video of the CCTV). He was unable to provide any evidence of bi-annual maintenance checks being carried out on the CCTV equipment and appeared to be unaware that this was a condition on his licence.

Mr Hambly also noted that there were no notices displayed asking patrons to behave and keep the noise down or asking people to avoid causing noise, nuisance or disturbance to local residents as required in the conditions of the licence. There were no risk assessments available relating to the licensing objectives.

Mr Hambly noted that the premises licence summary was kept in the shop, however it was behind the counter under the stairs and wasn't immediately visible to anyone attending the premises. When Mr Hambly asked where the rest of the licence was kept Metin stated that it was in his car.

Metin appeared to become quite agitated and I repeated what I had said to him earlier, that he didn't need to be so defensive when being challenged by people in authority. Metin told Mr Hambly that he wasn't picking on the right place and he needed to sort everywhere else out, at which point Mr Hambly left the premises.

I have met with Metin Mert more than 10 times over the course of the last 18 months in relation to licensing matters. He has always been very agreeable with me, however there is a noticeable difference in his demeanour when he is speaking to my manager. It has usually taken several visits to get him to do the things I have asked him to do in order to adhere to the conditions on his premises licence and he doesn't seem to understand the need to promote the licensing objectives during the course of running his businesses.

- 3.3 The licence holder shall notify the Police Licensing Unit on any occasion when the CCTV is to be inoperative for a period in excess of one working day and shall provide a certificate from a competent person stating the reason for the system being inoperative and the measures which have been taken to satisfy the licence conditions.
- 3.4 Bi-annually documented maintenance checks of the CCTV system, including the recording system, will be undertaken by the licence holder to ensure that the system is in good working order and fit for purpose.
