4. Call-In - Mill Street car park, Kirkham

Councillor Raymond Norsworthy (Chairman) explained the background to the item and made reference to the call-in procedure and sought clarification for the reason for the call-in.

Councillor Elizabeth Oades was invited to speak as a representative of the group of councillors requesting the call-in. Councillor Oades explained the reason for submitting the call-in and outlined her concerns regarding the Cabinets decision not to agree to the transfer of Mill Street car park and highlighted the need for an asset disposal policy to be put in place.

Councillor Roger Small (portfolio holder for Development and Regeneration) explained the position of the Cabinet's decision regarding this item. He endorsed the decision made at the Cabinet and made reference to previous and current car park maintenance budgets and expressed concern on how a charitable trust could maintain the car park and also made reference to the unrestricted sale value of the land.

Councillor Small went on to explain that it was the Cabinets intention to introduce a policy on Council assets.
