Background

The continuation of housing enforcement in line with the existing Private Sector Housing Enforcement Policy adopted in June 2019 and implemented on 1 August 2019, could potentially put staff and customers at increased risk of contracting Covid-19. It may not be practicable to undertake housing enforcement work in compliance with existing enforcement policies during the Covid-19 emergency.

In recognition of the potential impact of Covid-19 on housing enforcement work, the MHCLG have issued guidance to local authorities advising them to amend their housing enforcement policies for the duration of the emergency. Based on the above guidance, Fylde Council's Private Sector Housing Enforcement Policy has been revised and a revised policy agreed by the Director of Development and the Head of Governance.
