3. Exclusion of the Public

4. Allegations of Misconduct

Ms Manning advised members that a formal investigation had been instigated to establish the facts following a complaint made against Councillor Brian Gill following conferral with Mr. Clements, Independent Person. The investigation had been conducted by Mr Mark Towers, Monitoring Officer at Blackpool Council.

The report of Mr Towers regarding Councillor Gill outlined the allegation, background, evidence gathered, and other considerations. Mr Towers attended to introduce his report and assisted members of the committee by addressing questions and points of clarification. The views of the Independent Person were also provided.

A detailed submission from Councillor Gill had been circulated to members for review prior to the meeting and this was also considered as evidence.

It was RESOLVED:

- 1. To uphold the complaint that Councillor Gill had failed to follow the code of conduct and brought his office into disrepute by publishing social media posts which he knew to be significantly inaccurate about the value of council's investment into the catering facility and at the council meeting on March 3 2022, by continuing to imply that any decision of the Planning Committee on a future planning application in respect of the proposed catering facility would be tainted by bias or predetermination arising from members having already voted in favour of the design, location and layout, despite having been assured that this was not the case and having been given the opportunity to withdraw his remarks at the council meeting concerned.
- 2. To recommend that Councillor Gill undergo approved training on planning and social media and recommend to Councillor Gill's group leader that he should not in the new municipal year or afterwards be nominated for a position carrying a special responsibility allowance or for appointment to the Planning Committee until he has undergone such training.
- 3. That Councillor Gill should apologise to the complainant for the distress that has been caused to her.
