70. Medium Term Financial Strategy Update, Including General Fund, Capital Programme and Treasury Management for 2010/11 - 2014/15

Councillor Karen Buckley, Portfolio Holder for Finance and Resources presented the Council's budget and Medium Term Financial Strategy (including General Fund, Capital Programme and Treasury Management) for 2010/11 to 2014/15.

The report took account of the impact of the reduction in the financial settlement to the Council as outlined in the government's Comprehensive Spending Review.

After a full and detailed debate, and following a recorded vote it was RESOLVED:

- 1. That approval be given to the following
 - i) The Capital Programme for the years 2010/11 to 2014/15 as set out in Appendix F;
 - ii) The Revised Estimates for 2010/11 and the General Fund Budget for 2011/12 as set out in Appendix D, together with the savings proposals set out in Appendix E, including Fees & Charges;
 - iii) No increase in average Council Tax with an average Band D charge remaining at £186.29 in 2011/12 excluding Parish Precepts;

- To endorse the recommendations put forward by the Community Focus Scrutiny Committee with the exception of the proposal relating to the filming and webcasting of meetings;
- v) The Prudential Indicators and Minimum Revenue Provision Statement contained within Appendix G of the report; and
- vi) The Treasury Management Strategy contained within Appendix H, and the Treasury Management Policy and Updated Financial Procedure Rule contained in Appendix I of the report.
- 2. Further, to approve the following resolution:
- (i) that it be noted that the Section 151 Officer, under delegated authority, calculated the following amounts for the year 2011/12 in accordance with the Local Authorities (Calculation of Council Tax Base) Regulations 1992 (as amended) made under Section 33(5) of the Act:

"The Town Hall site should be included in the list of assets to be marketed. It may be that a less expensive, lower maintenance, smaller accommodation unit may be sufficient to meet the future needs of the Council; this would free up to £8.5m for our reserves and would enable us to pay off debt, freeing our residents from ongoing yearly debt repayments and taking pressure off the Revenue Budget, this would go some considerable way to achieve the savings this Council needs to make in the coming years, and would ensure that our services to the public are not affected in any way."
