#### **Prayers**

Prayers were offered by Reverend Wells.

## 1. Declarations of interest

Members were reminded that any disclosable pecuniary interests should be declared as required by the Localism Act 2011 and any personal or prejudicial interests should be declared as required by the Council's Code of Conduct for Members. There were none on this occasion.

#### 2. Confirmation of minutes

The Mayor proposed the minutes of the last meeting and the Deputy Mayor seconded the proposal.

Councillor P Collins proposed the following,

"an amendment to the draft minutes of the Council meeting held on 2<sup>nd</sup> March 2017 by replacing the words 'the amendment was lost' to 'the amendment was carried' in respect of the second amendment as proposed by Councillor Oades".

Following discussion and advice from the Head of Governance, a request for a recorded vote was received and supported by five members, therefore a recorded vote was taken and the amendment was LOST.

The proposal was carried and it was thereby RESOLVED to approve the minutes of the Council meeting held on 2 March 2017 as a correct record for signature by the Mayor.

## 3. Mayor's Announcements

The Mayor thanked everyone who attended and contributed to the Mayoral Ball, she advised that over £5000 was raised on the night. The Mayor commented on the many and various events she had attended and the wonderful, talented people she had met.

#### 4. Chief Executive's Communications

There were no communications from the Chief Executive.

## 5. Questions from Members of the Council

There were no questions from members of the Council.

## 6. Questions from Members of the Public

The following question from a member of the public was asked by Mrs Carol Lanyon, St Annes

"At the budget meeting held last month, mention was made again of the fact that St. Anne's residents are paying more in their council tax (Special expenses) than Lytham residents are, and that in effect St Anne's council taxpayers are subsidising Lytham's tax payers to the tune of approximately £21 for a Band D property. This seems to me to be grossly unfair and certainly not a robust and transparent method of collecting council tax. I would like to know A. The reason behind this accounting anomaly for charging special expenses across both areas. B. Why the development and supplies services budgets cannot be split between the two areas separately. C. What steps elected members of Fylde Council are going to take to address this issue, so that St. Anne's residents are not subsiding Lytham residents, as they are at present."

Councillor Karen Buckley responded stating that residents in the same council tax band of properties paid the same amount of special expenses regardless of whether they lived in Lytham or St Annes. For 2017/18 the special expense charge was £71.77 for a Band D property in each of the two areas. She advised that the only parks and open spaces owned by Fylde Council were in the Lytham St Annes area and accordingly Fylde Council had a special expense policy to charge for the maintenance of these assets. The policy expressly treated the whole area as a single tax base and charged the same amount to residents across the whole area. Councillor Buckley explained that the approach allowed for operational flexibility to the Parks Team in the delivery of the high standard of parks and open spaces across the whole area.

She further explained that elsewhere in the borough assets of this nature were owned and managed by Town and Parish Councils and the cost of their upkeep were charged to residents via the parish precept. She concluded by stating that the existing policy was clear and transparent.

The Mayor asked if Mrs Lanyon had a supplementary question, Mrs Lanyon asked

"Is Councillor Buckley suggesting that this method of taxation is considered to be equitable as residents of St Leonards ward, that I have spoken to, don't consider it to be so?"

Councillor Buckley responded advising that to charge Lytham and St Annes separately would be a departure from the approved method. The present method was open and transparent and the Council's policy on special expenses was reviewed every year.

#### **Decisions Items:**

#### 7. Confirmation of Leader and Deputy Leader 2017/18

Councillor Roger Small proposed that Councillor Susan Fazackerley and Councillor Karen Buckley be invited to accept the appointment of Leader and Deputy Leader of the Council respectively for the municipal year 2017/18.

Councillor David Eaves seconded the proposal, and it was RESOLVED to

- 1. Confirm Councillor Susan Fazackerley as Leader of Fylde Borough Council for the municipal year 2017/18; and
- 2. Confirm Councillor Karen Buckley as Deputy Leader of Fylde Borough Council for the municipal year 2017/18.

## 8. Confirmation of Committees and Allocation of Membership

Councillor Susan Fazackerley, Leader of the Council, introduced the report regarding the confirmation of committees and allocation of membership. Councillor Fazackerley explained that the allocation of the committee membership had been undertaken in accordance with the principles of political balance where applicable.

Councillor Fazackerley advised of a number of changes to committees requested by the Conservative group, namely Councillor Eaves would replace Councillor Taylor on the Chief Officers Employment Committee, Councillor Jacques would replace Councillor Taylor on the Environment, Health and Housing Committee, Councillor Harvey would replace Councillor Taylor on the Finance and Democracy Committee, Councillor Pitman would become Vice Chairman of Operational Management Committee and Councillor Settle would become Vice Chairman of Tourism and Leisure Committee.

Invited by Councillor Fazackerley to do so, Councillor Oades advised of a change requested by the Independent group, namely that Councillor Hardy would replace Councillor Speak on Environment, Health and Housing Committee.

Councillor Fazackerley moved and Councillor Karen Buckley seconded the proposal.

## It was therefore RESOLVED:

- 1. To appoint the committees as set out below for the municipal year 2017-18, with the terms of reference as presently set out in the constitution;
- 2. To allocate the committee seats in accordance with the principles of political balance as set out in the table below;

- 2. To request that the Member Development Steering Group consider extending its remit to include member wellbeing.
