## LICENSING ACT 2003

### THE LICENSING ACT 2003 (HEARINGS) REGULATIONS 2005

#### PROCEDURE FOR THE CONDUCT OF REMOTE HEARINGS

#### **1. Preliminary**

- 1.1. Under the regulations, the Licensing Authority is required to determine the procedure that it proposes to follow at any hearing under the Act.
- 1.2. During the restrictions associated with the coronavirus pandemic, Fylde's licensing panels will follow the procedure set out in this document instead of their normal procedure, subject to any changes that the panel makes for a particular hearing.
- 1.3. During this period all hearings will be held remotely. Participants and members of the public will access the hearing via the Zoom platform ([www.zoom.us](http://www.zoom.us)).
- 1.4. Any reference in this procedure to a hearing, or to participating in or attending a hearing, is a reference to a hearing held as set out on 1.3.
- 1.5. Please refer to the regulations for other rules about procedure

#### **2. Interpretation**

In this procedure, the following words or phrases have the following meanings:

applicant	an applicant for a licence or any person who has a licence which may be reviewed or revoked as a result of the hearing
act	The Licensing Act 2003
licence	Includes any consent or permission under the act
normal procedure	The procedure set out in the Fylde Council document "Procedure for the Conduct of Hearings"
panel	A sub-committee established by Fylde Borough Council under section 10 of the act
participant	A panel member, party, person representing a party, witness or council officer involved in the hearing
regulations	The Licensing Act 2003 (Hearings) Regulations 2003, and any reference to a numbered regulation is to the regulation so numbered in that statutory instrument
witness	A person given permission to appear at the hearing under regulation 8(2)

#### **3. Before the hearing**

- 3.1. At least ten days before the hearing, the panel will meet to consider:
  - 3.1.1. If the circumstances set out in regulation 9(1) apply, whether to dispense with holding a hearing;

- 3.1.2. What, if any, particular points it considers it will want clarification on at the hearing from a party under regulation 7(1)(d), and
  - 3.1.3. What time limit to set under regulation 24.
- 3.2. If it is not practicable for the panel to meet to consider these matters, the convenor may ascertain the views of panel members separately and give effect to the majority view as if it had been reached in a meeting of the panel.

#### **4. Opening the hearing**

- 4.1. The legal officer will identify all participants.
- 4.2. The legal officer will then explain to the parties the procedure to be followed at the hearing, specifically drawing attention to any departures from the procedures set out in this document and the reasons for them. The legal officer will also inform the parties that the proceedings will be recorded.
- 4.3. The panel will then consider any request by a party under regulation 8(2) for another person to appear at the hearing. The convenor will give any party who has made such a request (or their representative) which the panel proposes to deny an opportunity to address the panel about their request. The panel will then re-consider the request.
- 4.4. The convenor may invite any officer to carry out any functions under this paragraph.

#### **5. Zoom protocols**

- 5.1. The legal officer or any other officer nominated by the convenor will act as the host for the Zoom meeting, under the overall direction of the convenor.
- 5.2. Video and audio settings would be monitored and where necessary mandated by the host as set out below, unless otherwise directed by the convenor:

- 5.3. The host will hide participants whose video is off. This ensures that the only participants on screen are panel members, officers, representatives or parties representing themselves and any witness who is addressing the panel at that particular time.

## **6. *Listening to the parties***

- 6.1. Each of the parties will then be invited to:
- 6.1.1. Open their case by addressing the panel;
  - 6.1.2. Give any further information requested by the panel under regulation 7(1)(d);
  - 6.1.3. Present the evidence of any witness; and
  - 6.1.4. Conclude their case by addressing the panel.
- 6.2. The order in which the parties will be invited to put their cases will be in the discretion of the panel, except that a party who is an applicant will be invited to put their case last.

## **7. *Questioning the parties***

- 7.1. Members of the panel may, following the conclusion of the case of each party, ask questions of that party or any witness appearing for them.
- 7.2. A party or their representative may only question another party if they have asked for permission from the panel after the panel members have finished questioning that party or their witness. The panel will only give permission if it is satisfied that the questioning will provide useful information about a matter relevant to their determination which is unlikely to be placed before the panel without such questioning.

## **8. *Time limits***

Each party will be limited to the time set by the panel under regulation 24 in which to exercise their rights provided in paragraphs 6 and 7.2. The convenor will require the party or their representative to close their case or cease their questioning immediately this time limit is reached.

## **9. *Considering the decision***

- 9.1. The hearing will conclude after all parties have presented their case and responded to any questions. The panel will then deliberate on its decision by whatever means it considers to be appropriate.
- 9.2. The panel may, while it is considering its decision, seek advice from legal or licensing officers, either verbally or in writing. Officers will limit their advice to the specific issue identified by the panel.
- 9.3. When the panel has reached its decision, it may ask the legal, licensing or committee officers to review and offer observations on the draft decision notice.

## **10. *Communicating the decision***

- 10.1. The decision will be sent in writing to all parties in accordance with the regulations.

The Licensing Authority must therefore hold a hearing to consider the application.

  - (b) exclude a licensable activity from the scope of the licence
  - (c) to remove the designated premises supervisor
  - (d) suspend the licence for a period not exceeding three months
  - (e) revoke the licence
  - (f) take no further action

### **Application**

1. The application is to review the premises licence at The Willows, Bryning Fern Lane, Kirkham.
2. The premises was described on the initial application as *“a premises [which] will predominantly be used as a member’s club providing both alcoholic and non-alcoholic drinks to members as well as regular entertainment. In addition it is intended that the premises will operate a function room to be used by members and non-members for functions such as birthdays, wakes & christenings.”* A copy of the current licence is shown at appendix 3.

The joint applicants named on this form have either individually or collectively, such as through contacting the police, environmental protection, licensing, or the Residents meeting with the Willows Club on Tuesday 1st September 2020, attempted to resolve the issues that will be set out in this application. The residents meeting, for example, was an opportunity to discuss with the licence holder the experiences of the residents that reside in the vicinity of the Willows Club in regards to the general disturbances, and was also a moment to bring forward complaints and concerns to them. Unfortunately, the Club owner and management did not feel that the residents complaints were justified and suggested that any complaints and/or issues were more or less part and parcel of 'choosing' to live next to a club, notwithstanding that the size of the building greatly exceeds that which was originally on this site and as such carries a significantly larger footfall, or that the profile of the Willows has changed significantly, for example in terms of the cultural context (this is addressed in several of the statements that are attached to this application). The Willows Club ownership and management have clearly stated that the Willows is a 'business' interest that precedes any notion of community provision.

Licensing at Fylde has been contacted on numerous occasions since the beginning of the year (2020), in fact since the Willows Club opened. They have attended the premises to address these complaints.

Local Council have also expressed their concerns to the Willows Club and have asked them to address and resolve the complaints and concerns of residents.

Video evidence has been sent to Environmental Protection. I myself have utilised the Noise App but received no response to any submission in this context.

Therefore we feel that we have attempted to resolve issues before committing to the Licence Application Review process AND importantly, allowed the Willows Club such time as to address concerns and rectify their operating practices.

The evidence that is being submitted supports consideration of the Licence Review in all four areas or objectives.

We are providing such evidence as to support the view that the Willows Club is in breach of its responsibility to uphold these objectives. The **Complaints and Concerns statements**, submitted by the individual joint applicants provide a general testimonial overview of the issues as residents see them and have experienced them. (Please note that emails have been copied to Word documents so as to redact personal contact information. All original emails are available to the Review Panel if required) In fact, every statement makes note of at least two objectives, for example through witnessing fighting, foul language and excessive inebriation, broken glass and vomit on the surrounding pavements, urinating in the street and on residents properties, dangerous driving, drink-driving, excessive noise during opening hours and the lateness to which this extends etc. There are twelve statements from the signatories of the review application in the Complaints and Concerns folder.

- Importantly, several residents have complicated health issues that are potentially exacerbated by the disturbances and practices associated with the Willows Club (**see Complaints and Concerns folder, documents 1, 6 & 8 - Adrian Proniewicz, Cath & Wayne Webster, Jack & Janette Duckworth respectively**), while other residents can no longer use their homes as they would normally do, for instance moving children into other rooms so that they are able to sleep and/or do not have to witness the behaviour of the club's customers (**see Complaints and Concerns folder, documents 1, 5, 6 & 12**)

It is also important to note that all residents are incredulous that a club that necessitates the use of doormen/staff should exist in the first place in the midst of a quiet and close residential area.

We are submitting, along with the statements contained in the Complaints and Concerns folder, a number of folders containing video footage that is indicative of how the club operates. These communicate as many of the issues experienced by residents in the vicinity of the Willows Club. The video and still images span from August through to September 2020. As has been stated, the Club were contacted on several occasions earlier in the year about noise and disturbance, parking etc. as was Licensing, and, as indicated, residents were prepared to allow for a 'cooling period' to see if things would calm down, but, as soon as lockdown was lifted the club resumed its practices as before. It continues to use social media to promote itself as an 'entertainment venue' and to increase its reach and audience and we feel that it is unlikely that without some kind of critical review, the situation will continue as is. With the guidance of Licensing we have collated said evidence that covers an indicative period. What is contained in the video evidence is typical of what happens here when the Willows is operating in its 'entertainment venue' capacity.

Below is an inventory of the video footage. Not all videos have comments, however, they are indicative of the complaints and concerns that are being raised here. If comments exist it is because the video is of significant concern.

When I approach to buy our house we not been aware about Club will be renovated, we did find out about this on later stage through the process of buying our house. But when I spoke with the neighbours they told us club wasn't noisy in the past, people never complain.

But now it is noisy and it's a dangerous.

Concerns are:

1. People who are outside are really noisy, they smoking next to our fence, they not talking they are shouting whole night until 1am
2. People who are outside are using bad language
3. When there is lots of people who are smoking and when we have a wind coming to our house direction whole smoke coming straight to our garden and windows.
4. We are worrying about drunk people go over a fence to our garden, this is already happened to our neighbour from The Ferns 2

5. We are worrying about drunk people throw empty bottles straight to our garden, there is lots of empty bottles and glass on the street next day after parties

As residents of 87 Ribby Road, we have been adversely affected by the re-opening of the Willows Club. The rear of our property is at the junction where the access road to the club meets Bryning Fern Lane. The issues we have experienced are:

Damage to our rear garden fence (reported to club 10th August, club representative visited the following week and offered to pay for damage).

Vomit on the pavement outside our property

Club guests regularly urinating on our back wall

Regularly being disturbed/awoken up by antisocial behaviour/swearing/fighting outside our property

Regularly being disturbed/awoken up by revving engines, horns and wheel-spinning vehicles

Glasses/bottles discarded on our garden wall or at the rear of the property

The issues appear to have got worse over the last couple of months. I am writing this email to raise our concerns from 103 Ribby Road for the Willows club.

I must state that I feel I have been left with no choice but to do this after there has been no change since the club held a meeting for residence to discuss concerns and try to agree on solutions for the club to address these.

Right from the beginning we were informed via a letter that the club had applied for planning permission with no change of use (to be ran as a member clubs) to which we were supportive and thankful. However we were unaware and not informed about the application for changing the licence to an entertainment venue.

The willows itself is great for the community if it was to be used in the way it was intended, however it is essentially being ran as a pub/youth club which requires door staff, right in the middle of a residential area. Noise from the Willows when the door is shut is not an issue, which is due to the soundproofing they have put in place.

This issues the Willows causes is the noise from people outside, especially around closing time, which can last up until 1am.

The clientel the Willows attracts means, fighting, honking car horns, vandalism, uninating and vommiting on the clubs and residences property has occured regularly. This never happened when it was ran as a members club with a committee.

The Willows has caused parking issues especially along Bryning Fern. I fully understand this is not something the Willows can address as its not on their property, however it clearly shows there isn't enough parking at the Willows suggesting its not being used by the local community.

- Firstly we had cars parking on both sides of the road making it difficult for other vehicles to pass. Would have been impossible for emergency vehicles to get through.
- Parking across our neighbours dropped kerb thus blocking driveway. Then an argument ensued when they returned to the car.
- Noisy chatter and shouting from the club area which I assume must have been from the smoking area outside.
- As people left, there were a group of people in the middle of the road (Bryning Fern Lane), falling over, at one point a car nudged in to the back of a young girls legs because she refused to move.
- Speeding cars as they leave
- One group then were shouting and using foul language whilst waiting for their taxi.

Thank you for calling and your help with registering complaints re; The Willows Catholic Club Bryning Fern Lane.

I have owned my property since December 2009 and have lived there with my 2 children who are now adults.

Since I have lived in the property noise has never been an issue ...until recently when the club reopened after lockdown and just before around Xmas time I noticed a significant change.

Over the last 2/3 weekends however I am not sure what has happened at the Club as the noise levels, the crowds, the behaviour, the mess in broken glass (which I have had to clean up on a Sunday morning so I can walk my dog safely) has been awful.

I was woken at midnight on a Saturday night to a large crowd congregating on Ribby Road – shouting screaming about 30 people outside – there was a few people fighting and swearing .

I am getting so sick of the noise and behaviour, I've seen people urinating at the entrance to the club, drug deals taking place further down Bryning Lane which my husband has witnessed sitting in our back room in the middle of the afternoon on a Sunday. Men usually come out of the club turn right, take what looks like drugs and walk back after 2 mins – this is right outside peoples houses where children live also.

We are shocked at the change in the club in what it is now attracting to a residential area – surely this cant be right that this can happen to a residential area ? It is like living next to a nightclub. The old Willows was a lovely peaceful place to go with family – not this which is a different beast entirely. Can the owners & the council please explain what changed and why ?



- ⑦ Glass is frequently broken (bottles and glasses) along BF. Lane, the back alley of Ribby Road and Ribby Rd itself. Shouldn't security stop glasses and bottles being taken off the premises? (Health and Safety concern).

- ⑧ Neighbours from the Ferns have raised concerns about the noise and smells from the extractor fans as they are positioned in close proximity to their property. Also, they confirm that Kitchen doors and back doors of the Club are regularly open and noise/smells are becoming a serious concern. Can the extractor fans be re-directed to address this?, and doors etc remain closed?
- ⑨ Communication and relationships with the local residents is considered to be lacking. How can this be improved to achieve positive relationships with the Willows Club and local residents?
- ⑩ The houses along Ribby Rd and The Ferns seem to get excessive noise ~~for~~ coming from the Club during the opening hours. What can be done to address this, especially as "live" music doesn't seem to start until 9pm which is the watershed for children?

<p>The Review is brought by members of the public following concerns in relation to an adverse impact of all four of the licensing objectives.</p> <p>Therefore on behalf of the Police I submit the below evidence in relation to crime and disorder and public nuisance.</p> <p>The following is a list and short appraise of the reported incidents to the Police in relation to the above premises between 1<sup>st</sup> December 2019 to 24<sup>th</sup> October 2020:</p> <ol style="list-style-type: none"> <li>1) LC-20201002-1560: 20:59hrs Police received a report that the premises could be open beyond 10pm contrary to covid-19 restrictions. Police attend and premises in darkness.</li> <li>2) LC-20200831-1229: 17:49hrs anon report that the previous day a male was strangling a woman and hitting children inside the pub at approximately midnight. No further evidence/ complaints regarding this came to light.</li> </ol>				

- 3) LC-20200712-1549: 21:42hrs an email sent to Police stating the previous day at approximately 23:00hrs there was loud music coming from the club and they were concerned this was a covid breach.
- 4) LC-20200711-1817: 23:14hrs same informant from above reporting the same incident but at the time it was occurring; stating music was loud and people were dancing. Informant was told to contact licensing regarding this.
- 5) LC-20200307-0278: 04:44hrs female contacted Police to say she was locked inside the club and couldn't get out and she had set the alarms off. DPS attends premises and lets her out.
- 6) LC-20200229-1631: 21:57hrs Male reports he has been accused of taking drugs in the toilets of the club and he has now been refused entry, however he is requesting the Police attend as he wants to finish his pint. Advised this is a civil matter.
- 7) LC-20200111-1474: 22:21hrs a doorman has contacted Police to state he had prevented a male from hitting his own father and the offender has then turned and headbutted the doorman causing a bump to his chin. Offender was arrested and received a Police Caution for section 39 assault.
- 8) LC-20191229-0103: 01:35hrs Ambulance called Police as they had a 'call from a bouncer' stating there was a big fight outside and that a woman was having a fit, ambulance took her and her husband to Preston Hospital. Husband and wife later report that they were assaulted, and male had sustained a fractured jaw. A suspect was interviewed but due to conflicting accounts and no CCTV evidence as it had occurred further down the street, the suspect was released without charge.

The Police Licensing Department were first made aware of complaints in relation to this premises on 10<sup>th</sup> September 2020 by Chris Hambly from Fylde Council. Mr Hambly said there was a concern regarding social distancing and noise and that they had been given strong words of advice. Following this there was a concern that the premises may not close on time (10pm following covid-19 restrictions). Therefore, on Saturday 3<sup>rd</sup> October at 22:05hrs I attended the premises and it was in darkness and completely closed.

On 5<sup>th</sup> October I received the Application for a Premises Licence Review in relation to The Willows. As this application detailed concerns in relation to disorder, drugs and concerns regarding dispersal I contacted the DPS Richard Cochrane on 14<sup>th</sup> October. Ordinarily I would have conducted a visit to the premises but due to Covid-19 restrictions the premises were not open for the foreseeable future.

Richard Cochrane told me they had only been open two weekends since a residents meeting that was held to discuss concerns. He said all three exits were open due to covid restrictions in order to alleviate congregation and that on 13<sup>th</sup> September they had 4 door supervisors on duty, please leave quietly notices put in place, sound proofing, a 'covid tent' in place upon entry into the building and that they were operating at half their capacity (100 people) with tables 2 metres apart.

As several concerns are focused around dispersal/ gathering outside, I requested a documented dispersal policy be put in place which Mr Cochrane has since sent to me by email. I have also noted that on this policy it states the bar will close at midnight when the premises is licensed until 00:30hrs. Unfortunately, due to covid-19 restrictions this policy has

not been able to be implemented/tested as it has been closed. There is also a drug prevention strategy in place and staff have signed to say they have completed challenge 25 training and refreshers.

## The Willows – General Dispersal Policy

The Willows operates a “good neighbour” policy. The venue has always emphasised building and maintaining close relationships with the community in which it operates and it is run and managed accordingly. The management team are expected to deal with complaints from local residents quickly and effectively. In addition, The Willows ensures that it enjoys close working relationships with the statutory authorities including the police and the local authority to ensure that they are aware of any local issues.

In relation to dispersal; The Willows is aware of and operates the following procedures and systems, as required, to ensure that our venue operates in a neighbourly manner:-

- Effective management of customer behaviour whilst on the site. This is achieved through:
  - A good staff/management to customer ratio
  - Management presence front of house at all times
  - Well trained Door Supervisors who are aware of The Willows policies
  - A ‘community responsibility’ policy to minimise the risk of anti-social behaviour away from the premises
- When The Willows has hosted a band, they will have stopped playing by no later than 23:30hrs, lights will be on by this time and there will be no more music played
- Last orders will be 23:45hrs and the bar will close at 00:00hrs
- Security staff will oversee a prolonged dispersal of customers so as to ensure everyone does not exit the venue all at once. This will have the effect of reducing disruption caused by large numbers of people in the car park area





- Security staff will then escort all customers along the drive leading from the venue to further prevent disturbance caused by people not dispersing
- ONLY once all customers have left the property will security staff sign out and leave
- Appropriate signage will be placed at the exit doors
- Provide appropriate information to customers who require a taxi
- External disposal of bottles/refuse at a reasonable time

Experience has shown that The Willows tends to reach their peak occupancy at least an hour before closing time and therefore we do not anticipate being anywhere near capacity at closing time.

# The Willows

## **Drugs Prevention Strategy**

The premises Management operate a zero tolerance policy to all aspects of drugs use and the people using them.

We have a duty of care to any patrons in the premise who maybe under the influence of a substance. Should any person be found on the premise, they will be asked to leave the premise, with the assurance they are either in the company of a responsible person i.e.: friend; or they will be placed in a taxi to their home address. Should a patron require medical attention, the first aider will assist them in the first instance until a Paramedic arrives.

### **Known Offenders**

All people who are known to be drugs users or dealers will be barred from the premise. These barrings will either come from the local Pubwatch Scheme, or an in house bar.

Anyone who is found to be using/dealing on the premise will be automatically barred from the premise and will also be put forward to the Pubwatch Scheme for a Town Centre Banning Order.

All members of staff and doorstaff will have access to pictures of known offenders and will inform management immediately if an offender is in the premises.

### **Searches**

#### **Persons**

Doorstaff will conduct searches of any persons entering the establishment who they suspect to be carrying or using drugs. These searches will be conducted on the front door; clothing and bags will be searched by a member of the same sex. Anyone found already in the premises suspected of using drugs will be searched in a separate room with CCTV including audio and a minimum of 3 staff members present.

If a person is found with drugs on their person, the Police will be contacted immediately, with the person being held until the arrival of the Police.

Records of all searches will be available for the Authorities, and will be kept for a minimum of 6 months.

#### **Toilet Checks**

Toilets will not have a visible cistern, seat lid or a toilet roll holder, which is of a square shape. This will reduce the risk of drug taking from flat surfaces.

During busy periods, the toilets will be checked at a minimum of half hourly intervals by staff for signs of drug use.

These checks will be recorded and kept on the premises for a minimum of 31 days and will be available for inspection at any time.

### **Drugs records**

Any drug paraphernalia found, will be given to a member of management who will record the find in the book including date/time/location/finder/description/ref number. The items will then be placed in a sealed Police drugs bag and stored in a locked container until the Police collect.

### **Posters/Information**

Posters and leaflets informing patrons about drugs use and the dangers will be placed around the premises. These locations will include the toilets and the entrance hall.

### **Training**

All staff will receive training on the appearance of different forms of drugs, the dangers of using them and the symptoms of drugs use.

Training will be provided by a reputable company and will be held on a minimum of an annual basis.

Staff will also receive 'in house' training on the procedures for when drug paraphernalia is found, or if they have suspicion on a patron under the influence of a substance.

The first aider for the premises will have training with regard to how treat patrons with possible drug use symptoms.

### **Chill Out Area**

The premise has a chill out area, with soft lighting and music playing at a lower sound level.

Free tap water will be available for all patrons at all times the premises is open, as well as a plentiful supply of various soft drinks including bottled water.

## **The Willows Social Club**

I am currently employed as an Environmental Protection Consultant within the Environmental Protection Team at Fylde BC. I have been an Environmental Health Officer for 27 years and my main substantive role in that time was working for West Lancashire Borough Council. Before being made redundant in 2019, I had been the Environmental Protection and Community Safety Manager since 2002. I have spent the vast majority of my career working within Environmental Protection and thus am fully familiar with noise complaints and legislation. I have also participated in a number of similar reviews for music, anti-social behaviour and noise from people in the vicinity of a premises.

I was asked to consider the application for the Premises Licence review of the Willows Social Club and comment accordingly.

I understand the premises was previously a Catholic Club, but is now run effectively as a nightclub and attracts a significantly different clientele. The Club is bordered on three sides by residential accommodation and parts of the car park are directly behind residential accommodation. It is easy to foresee that a premises in such a position could cause problems for its neighbours. These can be predicted as coming from music, patrons and vehicles (doors, alarms etc).

The Environmental Protection Team received two complaints directly about the patron noise from the car park to the premises. These were received on 16.1.20 and 27.1.20. Due to the nature of the noise the Council's Licensing team were looking to lead on the complaints. A Premises Licence generally covers the patrons in the vicinity of the premises, and certainly covers the car park to a premises.

In addition to the complaints the Environmental Protection Team also received recordings of the noise being experienced by neighbouring residents. The Council uses a smartphone application called "The Noise App" which allows recordings to be made and sent directly to the team. In addition to a short recording of the noise, the user is also able to make comments and rate the noise. The location the

recording was made is also logged and shown to the officer. The first recording was made at 22.24 on 28.12.19. The noise was classified as “live music” and whilst some music is faintly audible, the predominant source of the noise is from people shouting outside the premises. Two recordings were received the following day (later that night) on the 29.12.19 from 00.09 and 00.30. Whilst one of these was described as being “loud music”, both recordings contain loud shouting from people outside the premises. I was also able to hear what sounded like glasses being put together, presumably having been taken out of the building. The Licensing Team were made aware of the recordings.

When the application for the review was received I reviewed the information included and watched the videos supplied by the numerous affected parties. I can confirm that whilst there are some slight differences in the videos, in general they all show anti-social behaviour from the club’s patrons, outside the premises. The behaviour exhibited includes:-

- Patrons shouting and swearing in the car park and by the entrances to the club
- People drinking in the car park
- Fights occurring on the car park and inside the premises
- Groups of people singing in the car park
- Taxis and other cars struggling through the patrons and beeping horns
- Multiple large groups under the influence of alcohol
- Males urinating

It is quite clear that there is no system for controlling and allocating taxis or separating taxis/vehicles from the public. It is also disappointing that whilst security staff can be seen a few times no one from the premises speaks to any patrons about noise and the patrons are not controlled or marshalled at all. They are free to congregate and wait around for vehicles etc. As a result of this the noise levels are excessive.

The management of the premises have greatly contributed to the disturbances created by their patrons and have no control over what happens in the car park area. As a result, large groups of people congregate and cause an unacceptable level of disturbance in a residential area.

Due to the age of the patrons attracted and the numbers visiting the club, I think it will be very difficult to reduce the patron noise to an acceptable level and reduce the impact of the patrons behaviour. Without a very robust noise management plan, which is tightly controlled, the location of this premises, operated as it is, will always result in some disturbance to local residents.

**LICENSING PANEL – THE WILLOWS CLUB, KIRKHAM**

To Members of the Licensing Panel,

As the Ward councillor for this area I would like to comment as follows:-

I have represented Kirkham South Ward for approximately 35 years, the area in which the Club is situated, during that time I do not recall receiving any complaints about The Willows Club.

The Willows Club has been in existence for as long as I can remember and has been used as a social club by many generations of local residents. Some two years ago the original building was demolished and a new Club was built in a larger footprint, no objections were received to the re-modelling and I did not receive any complaints or hear any doubts passed about the Club and its license. Town councillors were assured that it would be a facility for the community, a family facility, much improved for residents of Kirkham and the rural Fylde, these assurances were received in good faith.

As well as being the Ward councillor for the area I am also a resident of Ribby Road and have lived here for approximately 40 years, despite the fact that the road is very busy from a vehicular point of view, it is very quiet in other ways and a very pleasant area to live in.

I live quite close to the Conservative Club and, on occasion, there has been noise coming from the car park of that Club, when complaints have been made the Club has quickly apologised and rectified the situation.

In January, 2020, I received several complaints about a large fight which broke out on Ribby Road. This road is the main arterial route in Kirkham, and Bryning Fern Lane, which has a junction onto Ribby Road, is the access to the Club. As the fight occurred on New Year's Eve I had hoped that this would be a one off event and that there would be no more occurrences of this nature but unfortunately, after the end of the lockdown period, I received many complaints from a number of residents about noise outside the Club and in the car park, fighting in the car park, urinating and being sick in residential gardens, damage to fences and cars and general anti-social behaviour. It has also been reported that a car has been parking in Bryning Fern Lane, in the evenings at weekend, and young people have been observed coming from the Club buying drugs, the local Police have been made aware of this.

I would respectfully ask the Panel to take my comments into account when considering what action can be taken in relation to this review, in order that residents can return to living in peace, as is their right. It cannot be acceptable for a Club, surrounded by housing and within approximately 20 metres of residential bedroom windows, to allow anti-social behaviour to continue. It is not good enough for the proprietors to say that it is nothing to do with them once patrons are outside the Club and to rely on a Notice which asks patrons to respect residents' amenity.

**As the Club has operated well for many years I believe that it is possible for this to be the case in the future and I ask that you use all the tools in your arsenal to affect this.**

When I approached to buy our house we were aware about the Club being renovated, we did find out about this on at a later stage through the process of buying our house. But when I spoke with the neighbours they told us club wasn't noisy in the past, people never complained. But now it is noisy and it's a dangerous.

Concerns are:

1. People who are outside are really noisy, they smoking next to our fence, they not talking they are shouting whole night until 1am
2. People who are outside are using bad language
3. When there is lots of people who are smoking and when we have a wind coming to our house direction whole smoke coming straight to our garden and windows.
4. We are worrying about drunk people go over a fence to our garden, this is already happened to our neighbour from The Ferns 2
5. We are worrying about drunk people throw empty bottles straight to our garden, there is lots of empty bottles and glass on the street next day after parties
6. When club are closing at night time people who leaving are really noisy a cross whole street and round our house.
7. Fights at night time
8. People vomit next to our house
9. Customers from The Willow are parking them cars across whole our street, blocking the road. It's happened to me twice when I couldn't get back home because our road been blocked by parked cars. See attached photo.
10. More often a path to my door was blocked by cars parked on the footpath next to path to our house door. (our boy is on the wheelchair)

Our 8 years old boy is disabled. He is on the wheelchair. We are worrying about whole situation with The Willow what is going on up there. Oliver is suffer from seizures and noises over night could trigger this and give him unsettle sleep. We are worrying about our safety when already drunk people jumping over the fences. When we apply for a planning permission to build a fence on the front our boundary for our security this was refused by the planners but they allow to build this Pub next to us.

This is unacceptable.

We are planning to buy a special acoustic glass to keep noise down and buy new high fence, as high is possible. But why we need to spend this money, we shouldn't. This pub shouldn't be there, this is not anymore a club this is a PUB.

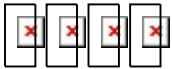

To whom it may concern

In relation to the pending licence review for The Willows Bryning Fern Lane Kirkham PR4 2BQ, as a resident of 1 Bryning Fern Lane, which is directly opposite the main access to the establishment we would like to make the following comments.

We have been residents in this property for over 18 years and are well versed with the local area and the previous Willows Catholic Club. We are aware of the investment and how the new venue was being used by different groups within the community, ie. family functions, christenings, bingo etc

In the early stages of the venue being open we raised concerns about the lights on the driveway being on all through the night, this issue was addressed promptly. Unfortunately the lights on the driveway are not working- having raised this as a concern-we are aware this is being addressed.

We raised further concerns when the venue re-opened after the lockdown. We were concerned about the noise and behaviour particularly as patrons were leaving the venue at the end of the evening - Friday night in particular. The management responded by inviting us in to discuss the matter. It was suggested to and agreed by the management to hold a Residents meeting , where residents could voice their concerns. The management asked for the questions in advance - these were collated and considered at the meeting.

Our individual concern was about the noise,anti social behaviour and safety of patrons leaving at the end of an evening and the suggestion was to review security measures in place, and that a member of security staff was to be present and visible along and to the end of the driveway when patrons were leaving with the objective to challenge inappropriate noise and behaviour . The management confirmed they had installed new signs asking patrons to respect the neighbourhood, these will be more visible on the driveway when the lights are working. The management acknowledged increased noise levels from inside the venue as part of their Covid risk assessment resulted in having the doors opened.

Another concern raised involved taxis collecting people at the end of the drive - the management confirmed they would communicate with local taxi firms to ensure patrons were collected by taxi outside the entrance to the venue. The management said they would contact the local constabulary to increase patrols around the venue to ensure everyone's safety and advised any resident to contact the police if they had serious concerns. Other residents raised their concerns in relation to noise and behaviour from individuals smoking in the car park, the smell from the extractor fans etc . The management said they would continue to discuss the issues raised and if residents had concerns in the future they could see Mr Cochrane at anytime and in a few months a further meeting could be held.

We believe from after the meeting until the venue closed again there were significant improvements for us in relation to our particular concerns, ie. the noise from patrons leaving the establishment. We are aware that a smoking shelter has been constructed, presumably with the intention of managing the number of patrons and their noise levels who go outside for a smoke.



### Appendix 3 - Representations

It is unfortunate ( but acknowledged ) that the venue has had to close again due to the present pandemic. Obviously a new venue of this standard is going to be popular- the residents meeting provided an opportunity to discuss concerns and for the venue's management to address these. Due to the pandemic and the venue taking the right decision to close , we consider the timing of this review has not given a realistic opportunity for their management to review and implement and re-assess fully their new procedures. We had noticed a positive improvement on the concerns we raised and we were grateful. We consider it to be a valuable asset to the community and have used it ourselves and would hope to in the future.

It is my understanding that there has been a request for a review of a premises licence for;

THE WILLOWS, BRYNING FERN LANE, KIRKHAM, PR4 2BQ.

As the longest residents within the vicinity of The Willows we can honestly state that there has been no increase in the noise volume.

We have lived on Ribby Road since the late 60's and have see the Willows grow from a small Catholic Club whose patrons were genteel, usually elderly and generally few in number, to a smarter, more up to date Club catering for people of all ages. A Club that is very much needed in Kirkham with the demise of so many of the Public Houses in the town itself.

As a result of this there are more patrons many much younger than the previously, and in all probability who would have been at the other end of Kirkham in the Post Office or the Black Horse prior to their demise.

Around the Club grounds there are very large posters asking the patrons to be considerate of the neighbours whilst outside the Club and when patrons are going home. As such we feel that the Management have and would continue to do all in their power to ensure that the request to be considerate to the neighbours is adhered too. They have also employed a Security Firm to help them. However, as all patrons are adults, we personally fail to see how the Management are expected to be responsible for behaviour once they have left the premises.

There are events, acts etc at the Club but again the noise volume is no greater than before in our opinion. We do attend the Club ourselves from time to time, as do some of the neighbours.

  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-
    - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
      - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
      - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
    - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
    - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
    - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
    - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

  - (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
    - (a) a holographic mark, or
    - (b) an ultraviolet feature.
4. The responsible person must ensure that-
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
    - (i) beer or cider: ½ pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml;
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

### Licensing Act 2003 (Mandatory Licensing Conditions) Order 2014

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
2. For the purposes of the condition set out in paragraph 1-
  - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
  - (b) "permitted price" is the price found by applying the formula-

$$P = D + (D \times V)$$

where-

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

### ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

2.1 Upon commencement of their employment, all staff who are involved in the sale of alcohol shall be trained in relation to the licensing objectives so as to reduce crime and disorder, promote public safety, prevent public nuisance and promote the protection of children from harm. Refresher training shall be provided at least once every six months and all training shall be documented and shall be made available to an authorised officer upon request.

2.2 A comprehensive CCTV system shall be installed at the premises and shall meet the following criteria:

- The system shall display on any recording the time and date of said recording;
- The system shall be recording whenever the premises is open to the public;
- Any recordings shall be retained for a minimum of 31 days after they are made and shall be produced to an authorised officer upon request, so long as said request is in accordance with the principles of the Data Protection Act or any subsequent or alternative legislation;
- As a minimum, the CCTV shall capture a "head and shoulders" image of persons entering the premises through the main public entrance.

- 2.3 Appropriate signage alerting customers to the use of CCTV shall be displayed in a conspicuous position at the premises.
- 2.4 A competent person trained in the use of and operation of the CCTV shall be in attendance at the premise at all times that licensable activities are taking place. Said person shall be able to fully operate the CCTV system and shall be able to download data in a recognised format when requested.
- 2.5 An incident register of any ejections from the premises shall be maintained at the premises and any details of public order offences shall be recorded. Said register shall be made available upon request to an authorised officer upon request.
- 2.6 Prior to any occasion on which licensable activities are to be carried on at the premises, a risk assessment shall be carried out to determine whether door supervisors are required. An appropriate number of door supervisors shall be utilised in accordance with said risk assessment.
- 2.7 The premises shall have a written zero tolerance drugs policy which is enforced at all times.
- 2.8 The premises shall be an active member of any local "pub watch" or equivalent scheme where such a scheme is in existence.
- 2.9 Any sales of alcohol made for consumption off the premises shall be made in a sealed container.
- 2.10 The management of the premises shall ensure that the area immediately outside the entrance to the premises is kept clean, tidy and free from litter.
- 2.11 External doors and windows shall be kept closed whenever entertainment is being provided, except for the purposes of access and egress.
- 2.12 On any occasion that regulated entertainment is carried on at the premises, regular assessments of the noise emanating from the premises shall be undertaken. Wherever said assessments indicate that noise is likely to cause nuisance to any local residents, remedial action shall be taken.
- 2.13 The premises shall have a written dispersal policy designed to encourage patrons to leave the venue and the area quickly and quietly.
- 2.14 There shall be no persons under the age of eighteen permitted on the premises after 21:00 each evening unless they are attending a pre-arranged private function or accompanied by a responsible adult.
- 2.15 A "Challenge 25" Policy shall be adopted and enforced at the premises whereby any person who appears to be under the age of 25 shall be required to provide identification to prove that they are over the age of 18 before they are permitted to purchase alcohol. The only forms of acceptable identification shall be:
  - A Passport;
  - A UK Photocard Driving Licence;

2.16 All staff who are involved in the sale of alcohol shall be trained in relation to the "Challenge 25" policy upon the commencement of their employment, following which they shall undertake refresher training at least once every six months. Said training shall be documented and shall be made available to an authorised officer upon request.
