Public Item

This item is for consideration in the public part of the meeting.

Summary

The Chief Executive has previously consulted with members on the prospect of granting Freedom of the Borough status to AFC Fylde (previously Kirkham and Wesham FC), winners of the 2008 FA Vase. Members have indicated their support for this. This report seeks to confirm the conferment of this title.

Recommendations

That in pursuance of section 249 of the Local Government Act 1992, members and representatives of AFC Fylde (previously Kirkham and Wesham FC) who won the 2008 FA Vase be admitted as freemen of the Borough in recognition of their eminent achievement.

That the common seal of the council be affixed to a certificate be presented to the Football Club conferring upon them this honour

Report

1. AFC Fylde have achieved great success in winning the 2008 FA Vase. This great achievement has given the club, the community of Kirkham and Wesham and the Borough national recognition. The victory was secured after a long campaign against significant odds and against opposition teams who regularly compete in football leagues that are regarded as a higher standard than the level at which AFC Fylde routinely compete. This is a unique achievement which testifies to their desire,

- commitment and abilities and one which bestows great pride on the community, the Borough and the County of Lancashire.
- 2. The council can confer the title of Freedom of the Borough to honour this success, by resolution passed by not less than two thirds of the members voting thereon at a meeting of the council convened specially for the purpose.
- 3. Following the making of this resolution, an Illuminated Record will be prepared to mark this honour and it is intended that this be presented to the Football Club at a date to be agreed by the Mayor of Fylde.
