### **Outside body appointments**

- 2. Where appointments change, or new outside bodies arise, outside of the normal cycle, nominations are still sought from the parent committee and ratified by the full council.

### **PATROL** and Sintropher working groups

3. Vacancies has arisen on the PATROL and Sintropher working groups following the resignation from the council of Councillor Albert Pounder. At the Operational Management Committee meeting, held on 14<sup>th</sup> November 2017, the committee nominated Councillor John Kirkham to represent the council on the PATROL and Sintropher Working Groups in place of Mr Pounder. Council is requested to approve the nominations.

#### **Arts Partnership for Fylde**

4. The former Arts Partnership for Lytham is now known as the Arts Partnership for Fylde and has a remit to cover the whole of Fylde Borough. The Tourism and Leisure Committee, at its meeting on November 2, resolved to seek the approval of the council to the new arrangements and, subject to such approval, that Councillor Ray Thomas remain as the council representative on the body. Council is therefore requested to formally approve the new arrangements.
