## **Prayers**

Prayers were offered by Ian Curtis, Head of Governance.

A minute's silence was held to honour the memory of former Councillor Hilda Wilson, who had recently passed away.

The Mayor welcomed Councillor Sally Nash to the Council following her recent election. He also offered his congratulations to Tracy Morrison on her recent engagement and forthcoming marriage.

#### 3. Mayor's Announcements

The Mayor advised that since the last meeting, the Mayor's Charity Ball had been held at which more than 200 guests attended. The Mayor extended his thanks to Mr Colin Ballard for acting as Master of Ceremonies at the ball and all his support during the mayoral year. The Mayor also spoke about attending a service of commemoration marking the centenary of the RAF which had been a most moving and humbling experience.

#### 7. Use of Section 106 Monies – M55-Heyhouses Link Road

Councillor Trevor Fiddler presented a recommendation for a fully-funded budget increase of £250,000 from Section 106 monies to enable detailed design work to be carried out for the M55-Heyhouses Link Road. He advised the funding was essential to ensure no unnecessary delays in work towards the link road.

Councillor Richard Redcliffe seconded the proposal, and it was RESOLVED

- 1. To approve a funded budget increase in the sum of £250,000 for 2018/19 to the M55 Link Road (design works) scheme that is within the current approved Capital Programme, to be met in full from \$106 developer contributions for delivery of the link road currently held by the Council for this purpose in the same sum; and
- 2. To note that the developer contribution is intended to provide funding for the design of the link road and consequently that payment of the total sum of £250,000 will be made to the appointed consultant engineering company and to Lancashire County Council in accordance with their respective costs.

#### 8. Confirmation of Leader and Deputy Leader 2018/19

Councillor Roger Small proposed that Councillor Susan Fazackerley and Councillor Karen Buckley be invited to accept the appointment of Leader and Deputy Leader of the Council respectively for the municipal year 2018/19.

Councillor Ben Aitken seconded the proposal, and it was RESOLVED to

- Confirm Councillor Susan Fazackerley as Leader of Fylde Borough Council for the municipal year 2018/19;

- 2. Confirm Councillor Karen Buckley as Deputy Leader of Fylde Borough Council for the municipal year 2018/19.
