1. Declarations of Interest

4. Fairhaven Lake Pathway Improvements Capital Scheme

The Chairman invited Tim Dixon (Tourism & Cultural Services Manager) to present the report. In summary, the report detailed a request for funding to undertake repairs and improvements to the pathways at Fairhaven Lake.

Members were advised that the scheme included works to several sections of pathway and the construction of a new path from the car park to the main circular lake path. The Committee was requested to approve a fully funded capital scheme addition in 2022/23 of £70,000 to be funded from the Capital Investment Reserve. Further details about this matter were set out in the report.

Included as an appendix to the report was a copy of the map of proposed works.

Following consideration of this matter it was RESOLVED to recommend to the Finance and Democracy Committee approval of a fully funded capital scheme addition in 2022/23 of £70,000 to be funded from the Capital Investment Reserve to carry out the works detailed within the report.

Information Items

5. Lowther Gardens Trust - Annual Report

The Chairman invited Tim Dixon (Tourism and Cultural Services Manager) to introduce the report

By way of introduction, Mr Dixon reminded members that the Council has in place a Service Level Agreement with the operating company of Lowther Gardens Trust, Lowther Gardens (Lytham) Management Ltd, to provide services at Lowther Pavilion. Mr Dixon explained that as part of the agreement, the Trust is required to provide a report to the Committee each year, summarising the performance over the previous year.

A copy of the Annual Report was included as an appendix to the covering report.

The Chairman then went on to invite Tim Lince, Chief Executive, Lowther Gardens (Lytham) Trust to present the Trust's 2021/22 Annual Report. In doing so, Mr Lince provided members with a summary of the performance over the previous year together with details of various challenges and achievements and other key points of interest arising from the report. In conclusion, Mr Lince thanked the Council for its support, help and advice through what had been a very difficult time for the creative industries. He added that in the face of adversity Lowther believed that it had laid the groundwork for a very exciting future in providing cultural activities for all generations going forward.

At the conclusion of the presentation, the Chairman invited questions from members of the Committee. Clarification was sought about the sessions made available for home schooled children. This was addressed by Mr Tim Lince

Councillor Sue Fazackerley, in her capacity as Fylde's representative on Lowther Trust, endorsed the 2021/22 Annual Report and in doing so, she commended the personal commitment of Tim Lince in driving forward the innovative Lowther vision. In addition, she went on to express her sincere thanks and appreciation to the Chair and the wider Lowther Team for the work that they do. This was further endorsed by the Committee.
