#### 64. Notice of Motion

Philip Woodward (Acting Chief Executive) reported that in accordance with rule 11.1 he had received a Notice of Motion that had been lodged by ????. The Notice of Motion, which was detailed on the agenda, sought to overturn the decision by the council to cease with immediate effect the Equitable Taxation model.

After the motion had been proposed and seconded the Mayor indicated that he was minded to apply council procedure 11.1.4.1 and allow the motion to stand referred to the Executive Committee for consideration. The Mayor invited the council to endorse his proposed action and the council RESOLVED to do so.

# 65. Appointment of Returning Officer and Registration Officer

lan Curtis (Legal and Democratic Service Manager) reported that in the absence of the appointed Officer it was necessary to update the Council's existing appointments in respect of elections of Councillors and the registration of electors

It was RESOLVED that until such time as a Chief Executive was appointed and in office that Philip Woodward (Acting Chief Executive), be appointed:

- Under the provisions of Section 35(1) of the Representation of the People Act 1983, as the Returning Officer for the elections of Councillors of the Borough and for the elections of Parish Councillors
- 2. Under the provisions of Sections 83 and 84 of the Local Government Act 1972, as the Proper officer of the District Council, to receive Declarations of Acceptance of Office of Mayor, Deputy Mayor or Councillor, and any notice of resignation from those offices
- 3. Under the provisions of Section 89(1) of the Local Government Act 1972, as the Proper Officer of the Borough Council to receive notice of a casual vacancy in the office of councillor
- 4. That Mr. Peter Welsh be appointed to perform the duties allocated to Mr. Woodward under paragraphs (2) and (3) above in the event of his incapacity to act or in his absence
- 5. That Mr. Woodward be appointed under the provisions of Section 8(2)(a) of the Representation of the People Act 1983 to be registration officer for the part of the Fylde Parliamentary Constituency contained in the District of Fylde and that Mr. Welsh be appointed to perform the duties herein before allocated to Mr. Woodward in the event of his incapacity to act or in his absence.
- 6. That following the appointment of a new Chief Executive the above designations be subject to a further review.

#### 66. Allocation of Committee Membership

It was RESOLVED to defer consideration of this matter to the next meeting of the Executive Committee.

## 67. Members Choice Debate (Lancashire Locals)

At the last council meeting, Councillor Christine Akeroyd had been selected to lead the members' choice debate.

Councillor Akeroyd had invited representatives from Lancashire County Council to address members on Lancashire Local in Fylde. In attendance were, Councillor Council Doreen Pollitt (Deputy Leader LCC) Ben Spinks (District Partnership Officer for West Lancs) Debbie Thomson (District Partnership Officer for Fylde) Cliff Matthias (Director of Highway Consultancy)

The presentation focused on the thinking behind and the main features of Lancashire Local; what decisions were likely to be devolved; the opportunities for District Councils; some frequently asked questions and proposed action from December onwards.

At the conclusion of the presentation there was an opportunity for a question and answer session following which the Mayor thanked all concerned for their informative presentation.
