ST ANNES TOWN CENTRE AND ISLAND MASTERPLAN					

PUBLIC ITEM

This item is for consideration in the public part of the meeting.

SUMMARY

The work commissioned to produce a masterplan for St Anne's Town Centre and the Island is nearing completion and this report presents the final draft of the masterplan to Members for consideration.

If the masterplan is accepted, it will be used to guide future investment in the town, to support applications for grant funding and to help secure Sn 106 contributions from future developments in the area.

RECOMMENDATIONS

- 1. That, Members consider the final draft of the St Annes Town Centre and Island Masterplan and that, subject to the incorporation of any amendments that the Committee consider necessary, adopt the masterplan as a framework to guide future investment and development projects in the resort.
- 2. That the St Annes Town Centre and Island Masterplan and companion documents be used to support applications for grant funding and to secure financial contributions from developments (Sn 106) in the borough to ensure the future vitality of the town centre and the island.

REPORT

BACKGROUND

- The Planning Committee, at its meeting on 16 September 2020, recommended that the Finance & Democracy Committee approve a revenue budget increase for 2020/21 in the sum of £150,000, funded from the Funding Volatility Reserve, to provide for the commissioning of a town centre health check and town centre strategy for St Annes. This was approved by the Finance and Democracy Committee on 28 September 2020.
- 2. On 28 July 2021, The Planning Committee considered a further report on the success of an application to the Lancashire Economic Recovery & Growth Fund to produce a Masterplan for the Island site on the sea front. Members agreed to recommend to the Finance & Democracy Committee approval of a fully funded revenue budget increase of £120,000 for 2021/2022, of which £108,000 is funded from the Lancashire Economic Recovery Grant from Lancashire County Council and a further £12,000 is funded from the funding volatility reserve for the commissioning of the Island Regeneration Programme Masterplan. This was approved by the Finance and Democracy Committee on 29 July 2021.
- 3. The commission was awarded to a team of consultants headed by BDP who initially compiled a suite of baseline reports including: a town centre health check, a review of the local property market, socio-economic conditions, visitor economy, townscape and movement appraisal. These reports, alongside the views of key stakeholders, informed the development of a range of possible options which were the subject of a wide-ranging public consultation exercise that took place from 14 March to 1 April 2022 (see section 5 of the draft Masterplan).

THE MASTERPLAN

- 4. The final draft of the masterplan has now been produced and is included as appendix A to this report. The overall masterplan illustrates a comprehensive vision for the seafront and town centre. The 'Square' (St Anne's Road West) and the Island Site (specifically the Boating Lake, YMCA swimming pool and the Pleasure Island development) are seen as the key transformational developments but it is important to maintain the wider vision of a better-connected town centre and seafront and the idea of a continuous and high quality experience for resident and visitor alike, from the station gateway to the Fairhaven car park via the Square, Pier Link and Promenade. The vision is of a seamless promenade, extended from the seafront and through the town centre.
- 5. The plan identifies a vision for the future development of the Town Centre and promenade over the next 5 to 10 years and will underpin applications for future bids for grant funding that will support town centre regeneration, including the Levelling Up fund. The masterplan identifies 7 key projects:
 - a) The Station Gateway transformed arrival experience.
 - b) The Square a multipurpose, flexible town centre heart that better accommodates the diversity of use of future town centres
 - c) The Pier Link extending the Square to ensure a strong connection with the seafront
 - d) The Pier rediscovering the value of this key seafront heritage asset
 - e) The Island Site lifting the visitor experience of the seafront to a new level
 - f) Promenade Gardens promoting active linkages and family friendly fun
 - g) South Gateway a new southern gateway to St Anne's, a new seafront destination and an active travel hub.
- 6. A Transport and Movement Strategy forms a key part of the masterplan and will look to encourage more active forms of travel. This strategy also recognises that, once the M55 Heyhouses link road is complete, more visitors will arrive at the eastern side of the town and that more visitors will arrive by rail if the frequency of the rail service can be improved.
- 7. A Destination Management Plan, which will help develop the role of St Anne's as a quality visitor destination, is also being drafted as part of the commission.

DELIVERY

8. In addition to the above, the BDP team is also preparing a Delivery Plan which will set out a recommended approach to the implementation of the key proposals and outline the key outputs and benefits for each phase of the works. Ultimately, the speed of implementation is a product of several factors, including the capacity of the Council to manage the programme, the availability of public sector funding to deliver enabling infrastructure and otherwise address viability gaps, the appetite of the private sector and other public sector bodies to progress developments including the availability of development finance, and the market and demand for the additional facilities and services that are proposed.

GOVERNANCE

9. The commission has been overseen by the Town Centres Working Group and the St Annes Programme Board to ensure the proposals are aligned with and complement other projects being progress by the council in the town.

CONCLUSION

10. The final draft of the masterplan is attached as Appendix A. Members are requested to consider the final draft Masterplan and adopt it with or without amendments.
