REPORT

- 1. On 26 March 2013 the Government passed the Mobile Homes Act 2013 which is designed to give greater protection to occupiers of residential mobile (park) homes.
- 2. The Act allows the Council to set fees for the following statutory functions in respect of residential park homes only, for-
 - Application fee for a new site licence;
 - Annual site licence fee;
 - To transfer and existing site licence;
 - Altering a condition to an existing site licence;
 - Depositing site rules;
 - Fees for enforcement action and statutory notices.

- 3. The Licensing Team are looking to amend a number of administrative details of the Mobile Home Fee Policy for 2017-2018.
- 4. On reviewing the Mobile Home Fee Policy 2016-2017 the following amendments are to be made-

Paragraph 2.10 first line to remove the number "...2016..." and replace the number with "...2017...".

Paragraph 2.10 first line to remove the number "...2017..." and replace the number with "...2018...".

Paragraph 9.2 first line to remove the number "...2017." and replace the number with "...2018.".
