#### 40. Council accommodation

Philip Woodward (Executive Director) informed members that the Council had previously resolved to receive reports relating to the location and design of the replacement Civic Suite and make decisions thereon. Several suggestions had been made on what should be

included in the Suite and where it could be located.

The report (which was circulated with the agenda) presented the detailed feasibility and options appraisal work undertaken to investigate the options proposed. As some of the options impinged upon the provision of the proposed new back-office facility, the report also contained information about the potential impact on this element of the Council's wider accommodation project. Details of various accommodation options together with costings were also included in the report for consideration.

After discussing the various options available, and following a recorded vote, it was RESOLVED -

- 1. That the Council agree in principle to option 2 (that the back office facility be located at Wesham and that a new full commercial civic suite be built on the public offices site).
- 2. That officers be instructed to find the most practicable options to realise the best rental return from marketing this facility for public use.
- 3. That the final design of the Civic Suite be subject to the final approval of the full Council, with the Executive committee being updated on progress along the way
- 4. The Leader's and opposition leader's office, along with the Mayor's secretary to be located in the back office facility
- 5. That the Chief Executive be authorised to appoint agents to deal with the marketing of the Council's development sites identified as contributing to the funding of the accommodation project.
