CORONAVIRUS: POWER OF DIRECTION				

PUBLIC ITEM

This item is for consideration in the public part of the meeting.

This item is recommended by officers to be considered by the Mayor as an urgent item under Section 100B(4)(b) of the Local Government Act 1972.

SUMMARY

As lockdown restrictions are eased, new regulations have been made giving upper tier authorities power to take targeted actions to combat local outbreaks of coronavirus. Those regulations contain a power for a county council to direct a district council to exercise its powers in a specified way in order to combat the coronavirus. The report asks council to delegate power to the chief executive to comply with such a direction, should one ever be issued.

RECOMMENDATION

1. Delegate the following power to the Chief Executive "Power to exercise any of the district council's functions in a way specified in a direction issued by Lancashire County Council under regulation 17 of the Health Protection (Coronavirus, Restrictions) (England) (No.3) Regulations 2020".

REPORT

- 1. New regulations¹, which came into force on Saturday, made provision for upper tier local authorities like Lancashire County Council to give directions to close or restrict access to premises, events and public outdoor places in its area. A direction may only be given if the upper tier authority considers that there is a serious and imminent threat to public health and that that the restrictions are necessary and proportionate to combat coronavirus.
- 2. The regulations also allow a county council to direct a district council to "exercise any of the district council's functions in a specified way...if it considers that it is necessary and proportionate to do so in order to prevent, protect against, delay or otherwise control the incidence or spread of infection by coronavirus in the district council's area". Any such direction, if ever issued, would be binding on the borough council and would need to be urgently actioned. Accordingly, it is recommended that the authority necessary to comply with such a direction be delegated to the chief executive.
