**1. About the person** Say a little about them e.g. their age, if they live alone, their general well-being, if they have family or friends nearby etc

Mrs B is 66 years old and lives alone in a property which she owns. She has suffered with back problems due to traumas received and a fracture to the lower back and pelvis. She also has nerve damage to her right calf due to a torn qastrocnemius muscle. Her conditions cause her severe pain and make her feel vulnerable and sad.

**2. What was their situation?** How did they come to be involved in the project or service? What was the issue they were facing and how was it affecting them?

Due to difficulty with her personal care, Mrs B contacted Age UK Lancashire for help in completing a claim form for Attendance Allowance. We assisted with the claim form and sent it to the relevant department. We also completed a wellbeing check list and made a referral to social services for a care needs assessment. A blue badge application was completed online and a benefit check form was issued to Mrs B in order for us to carry out a calculation to check for any other benefits she may be entitled to.

#### 3. What did Age UK do that made a difference?

Mrs B was awarded the Higher rate of Attendance Allowance. Her blue badge application was successful and she received a Blue Badge. Social services contacted her regarding a care needs assessment. Our benefit calculation confirmed Mrs B was entitled to Pension Credit and Council Tax support. She is now entitled to the Warm Home Discount under the core group due to her Pension Credit award.

**4. What outcomes did you achieve?** How has becoming involved changed their life? Unclaimed benefits amounting to £8684.52 per year.

Blue badge gives Mrs B much more freedom and independence.

Mrs B's general wellbeing has improved. She feels more independent and not as isolated. She has more choices financially and has regular private physiotherapy.
