# 1. Declarations of interest

### 3. Complaint about the conduct of Councillor Simon Renwick (SC5)

The sub-committee considered an investigation report by the Monitoring Officer about a complaint that Councillor Renwick had breached paragraphs 3.1, 3.2.2 and 5 of Fylde Borough Council's code of conduct.

The sub-committee RESOLVED:

- 2. to refer the allegation of a breach of paragraph 3.1 of the code of conduct to a hearing before a further meeting of the sub-committee for determination in accordance with the Standards Committee (England) Regulations 2008.

- 3. to refer the allegation of a breach of paragraph 8(1) of the code of conduct by Councillors Burn, Delany, Dowling, Fiddler, Foster, Greenhough, Rigby, Robb, Threlfall and Willis in relation to an item about the payment of subscriptions for membership of the Rawstorne Centre to a hearing before a further meeting of the sub-committee for determination in accordance with the Standards Committee (England) Regulations 2008.
