**Schedule of Evidence** 

March 2020

## **Introduction**

The policies in the adopted Fylde Local Plan to 2032 (FLP32) are based on up-to-date and relevant information. This information is referred to as the evidence base. As part of its preparation for the Partial Review of the Fylde Local Plan to 2032 the Council has checked the evidence base to see if any of it needs updating. This analysis was based on the joint objectives of the partial review which are to reflect the policy changes of the replacement NPPF2019 and the early review triggered by paragraph 1.27 of the FLP32.

Most of the revisions needed to FLP32 to produce the partial review are minor and do not require the relevant evidence to be updated. More significant changes are needed with respect to the Duty to Co-Operate and the housing requirement figure, which used the standard methodology. These did not require updates to the existing evidence base either however, a Housing Need and Requirement Background Paper 2020 and a Draft Statement of Common Ground have been produced in house.

Updated technical assessments of the Partial Revision have been carried out. These include Viability Appraisal, Sustainability Appraisal and Habitats Regulations Assessment. The technical assessments will be published at the Publication stage of the Partial Revision of the FLP32. The proposed schedule of revisions has been screened for Health Impact Assessments.

Table 1 provides the schedule of updates to the evidence base that are required to support the submission and publication of the Partial Review of the FLP32.
