1. Declarations of interest

2. Confirmation of minutes

RESOLVED: To approve the minutes of the Community Outlook Forum meeting held on 17 October 2005 as a correct record for signature by the chairman.

3. Substitute members

There were no substitute members.

4. Update on partnership working from citizens advice bureaux and age concern

Citizens Advice Bureaux

Members received a detailed report and presentation from the managers of the Kirkham and St Annes Citizens Advice Bureau (CAB), which provided members with detailed information on the role and activities, provided by CAB. A copy of the PowerPoint presentation made by the CAB Managers is attached for information.

Following the presentation members questioned whether any external funding had been obtained and what progress had been made for merging the two management boards.

Age Concern

Members received a report from David Wilkinson (partnership lead officer), which provided members with a detailed update on the levels of activity undertaken by Age Concern since 1st April 2005.

Following consideration of the above the Forum RESOLVED

- That the Citizens Advice Bureaux and Age Concern be asked to report back to the Community Outlook Forum in February and quarterly thereafter and detailed within the reports information should be provided about the expenditure of the respective organisations in so far as Borough Council grant is concerned.
- 2. That the Community Outlook Forum acknowledge that the level of performance information provided by the both the St. Annes and Kirkham Citizens Advice Bureaux has improved significantly and a valuable service is provided but it is felt that more progress could have been made on the two organisations exploring joint working and funding opportunities.
- 3. That the Community Outlook Forum recommend the Executive Committee that both Age Concern and the Citizens Advice Bureaux should continue to receive the financial support of the Borough Council but that this is kept under review by the mechanism detailed in 1 above and through liaison with the Council's Lead Officer on this matter.
- 4. That a Lead Officer be identified to undertake the liaison work with both the Citizens Advice Bureaux and Age Concern in light of the departure of the present Lead Officer
- 5. That Councillor Kiran Mulholland be nominated to present the findings of the Forum to the Executive Committee.

5. Update report on the review of outside bodies

Carolyn Whewell (Overview and Scrutiny Officer) provided members with a progress report on the review of outside bodies and informed the Forum that only 50% of councillors had returned the questionnaire and approximately 40% of questionnaires had been returned from outside bodies.

Following consideration the Forum RESOLVED

- 1. That a reminder letter to be signed by the Chairman of the Forum and sent out to all Councillors and outside bodies who had not returned their questionnaires.
- 2. That the analysis of the results be deferred until February 2006.

6. Overview report on the National Smoking Policy and trends throughout the country

Carolyn Whewell (Overview and Scrutiny Officer) provided members with an update on the Governments proposals for a partial ban on smoking in enclosed public places. The report also detailed smoking trends and some of the arguments for and against such a ban.

Members RESOLVED to note the current position of Government Policy on Smoking in public places

Total Client problems 2003/05


In 2003/2004 Kirkham CAB dealt with 3,424 client problems




Our volunteers – the bedrock of the service




Workers at Kirkham CAB
