## 4. Draft Biodiversity Supplementary Planning Document

Julie Glaister, Planning Policy Manager, presented the draft Biodiversity Supplementary Planning Document prior to any further work and sustainability appraisal being carried out. The draft SPD would be required to be put out for consultation and members would have a further opportunity to consider the SPD later in the year to consider any comments received as a result of the consultation exercise.

Mrs. Glaister provided a brief overview of the type of areas covered in the SPD and that the SPD would be updated following new advice published by Natural England prior to going to consultation.

Stephanie Shone, Planning Policy Officer, presented the draft Healthy Living Supplementary Planning Document prior to any further work and sustainability appraisal being carried out. The draft SPD would be required to be put out for consultation and members would have a further opportunity to consider the SPD later in the year to consider any comments received as a result of the consultation exercise.

Miss. Shone explained that the SPD incorporated the principle of the Wyndyke Garden Village proposals and the guidance published by Lancashire County Council on hot food takeways near schools. The document would ensure that community facilities were considered and provided for in planning applications.
