69.Mayor's announcements

- 1. Mr William Taylor The Mayor welcomed William Taylor (interim Chief Executive) to the Borough Council.
- 2. Councillor Karen Henshaw The Mayor informed members that Councillor Karen Henshaw was currently being treated in hospital.
- 3. Major Frank Hoyle The Mayor reported that Major Frank Hoyle (former member of the council and consort to the Mayor) was seriously ill in hospital.

70. Interim Chief Executive's communications

- 1. Performance of the Borough Council Mr Taylor indicated that the performance of the borough Council was very good in some areas and had many examples of good working practices.
- 2. Closer working Mr Taylor informed members that he expected to continue the work of exploring closer working relationships with Wyre Borough Council.

71. Member's Question

The following question was put from Councillor Elizabeth Deborah Clarke:

"Has the relevant member of the Executive Committee given any thought as to what we might be able to do, as a council, to promote a greater sense of respect not only for each other as councillors but, more importantly, for the position of the Mayor?"

Summary of response from Councillor John Coombes:

"We have an ideal opportunity at the moment to address this issue through a number routes including the development of a new Constitution and a review of the role of the Standards Committee. We also propose to use the Improvement and Development Agency in the New Year to work with us on ethics and standards issues by providing advice and guidance on best practice from other councils across the country.

However, to encourage the greater sense of respect that my colleague refers to, we will need the support of all members and the willingness of all political groups to help restore confidence in our reputation."

72. Decision Making Arrangements - Outcome of Consultation

Philip Woodward (Deputy Chief Executive) reported on the results of the consultation exercise in respect of the Council's new governance arrangements.

Full details of the consultation process and supporting evidence together with information on responses received were circulated with the Council agenda. An update on the responses received after the closing date was reported at the meeting.

Members were advised that the consultation process was legally robust and satisfied the requirements of the Office of the Deputy Prime Minister.

After a lengthy and detailed debate, and following a recorded vote, the council RESOLVED to confirm its intention to move to executive arrangements based on a Leader and Cabinet model.
